

AMENDMENT TO THE RULES COMMITTEE PRINT

OFFERED BY MR. PETERS OF CALIFORNIA

Add at the end of subtitle E of title VIII the following new section:

1 SECTION 1. CODIFICATION OF SMALL BUSINESS ADMINIS-
2 TRATION SCORECARD.

3 (a) IN GENERAL.—Section 868(b) of the National
4 Defense Authorization Act for Fiscal Year 2016 (15
5 U.S.C. 644 note) is transferred to section 15 of the Small
6 Business Act (15 U.S.C. 644), inserted after subsection
7 (x), redesignated as subsection (y), and amended—

8 (1) by striking paragraphs (1), (6), and (7);

9 (2) by redesignating paragraph (2), (3), and (4)
10 as paragraphs (1), (2), and (3), respectively;

11 (3) by redesignating paragraph (8) as para-
12 graph (6);

13 (4) in paragraph (1) (as so redesignated), by
14 striking “Beginning in” and all that follows through
15 “to evaluate” and inserting “The Administrator
16 shall use a scorecard to annually evaluate”;

17 (5) in paragraph (2) (as so redesignated)—

1 (A) in the matter preceding subparagraph

2 (A)—

3 (i) by striking “developed under para-
4 graph (1)”;

5 (ii) by inserting “and Government-
6 wide” after “each Federal agency”; and

7 (B) in subparagraph (A), by striking “sec-
8 tion 15(g)(1)(B) of the Small Business Act (15
9 U.S.C. 644(g)(1)(B))” and inserting “sub-
10 section (g)(1)(B)”;

11 (6) in paragraph (3) (as so redesignated)—

12 (A) in subparagraph (A), by striking
13 “paragraph (3)(A)” and inserting “paragraph
14 (2)(A)”;

15 (B) in subparagraph (B), by striking
16 “paragraph (3)” and inserting “paragraph
17 (2)”;

18 (7) by inserting after paragraph (3) (as so re-
19 designated) the following new paragraph:

20 “(4) ADDITIONAL REQUIREMENTS FOR SCORE-
21 CARDS.—The scorecard shall include, for each Fed-
22 eral agency and Governmentwide, the following in-
23 formation with respect to prime contracts:

24 “(A) The number (expressed as a percent-
25 age) and total dollar amount of awards made to

1 small business concerns owned and controlled
2 by women through sole source contracts and
3 competitions restricted to small business con-
4 cerns owned and controlled by women under
5 section 8(m).

6 “(B) The number (expressed as a percent-
7 age) and total dollar amount of awards made to
8 small business concerns owned and controlled
9 by qualified HUBZone small business concerns
10 through sole source contracts and competitions
11 restricted to qualified HUBZone small business
12 concerns under section 31(c)(2).

13 “(C) The number (expressed as a percent-
14 age) and total dollar amount of awards made to
15 small business concerns owned and controlled
16 by service-disabled veterans through sole source
17 contracts and competitions restricted to small
18 business concerns owned and controlled by serv-
19 ice-disabled veterans under section 36.

20 “(D) The number (expressed as a percent-
21 age) and total dollar amount of awards made to
22 socially and economically disadvantaged small
23 business concerns under section 8(a) through
24 sole source contracts and competitions re-
25 stricted to socially and economically disadvan-

1 tagged small business concerns, disaggregated by
2 awards made to such concerns that are owned
3 and controlled by individuals and awards made
4 to such concerns that are owned and controlled
5 by an entity.”;

6 (8) in paragraph (5), by striking “section
7 15(h)(2) of the Small Business Act (15 U.S.C.
8 644(h)(2))” and inserting “subsection (h)(2)”; and
9 (9) by amending paragraph (6) (as so redesign-
10 nated) to read as follows:

11 “(6) SCORECARD DEFINED.—In this subsection,
12 the term ‘scorecard’ means any summary using a
13 rating system to evaluate the efforts of a Federal
14 agency to meet goals established under subsection
15 (g)(1)(B) that—

16 “(A) includes the measures described in
17 paragraph (2); and

18 “(B) assigns a score to each Federal agen-
19 cy evaluated.”.

20 (b) CONFORMING AMENDMENT.—Section 15(x)(2) of
21 the Small Business Act is amended by striking “scorecard
22 described in section 868(b) of the National Defense Au-
23 thorization Act for Fiscal Year 2016 (15 U.S.C. 644

1 note)” and inserting “scorecard (as defined in subsection
2 (y))”.
