9 "§ 2806a. Contributions to improve the climate resil10 ience of certain facilities of allies and
11 partners of the United States.

12 "(a) CONTRIBUTIONS.—From amounts appropriated 13 to carry out this section, the Secretary of Defense may 14 make contributions to the Federal share of the cost of con-15 struction, and other projects, to preserve or improve the 16 climate resilience of—

17 "(1) military facilities and installations of an18 ally or partner of the United States; or

1 "(2) a civilian airfield or seaport of an ally or 2 partner of the United States that the Secretary de-3 termines is suitable for military use. "(b) LIMITATION ON CONTRIBUTIONS.—Funds may 4 not be obligated or expended pursuant to this section un-5 less such funds have been authorized by law for such pur-6 7 pose. 8 "(c) Additional Contributions.— 9 "(1) The Secretary may make an additional 10 contribution for a construction or other project for 11 which the Secretary has made a contribution under 12 subsection (a) if— 13 "(A) such additional contribution is in an 14 amount that is greater than the amount appro-15 priated to carry out this section; and "(B) the amount of the additional con-16 17 tribution is not greater than 200 percent of the

18 maximum amount specified in section 2805(a)
19 for a minor military construction project.

20 "(2) An additional contribution described in
21 paragraph (1) may exceed the limitation in such
22 paragraph—

23 "(A) if the sum of the additional contribu24 tion and the contribution under subsection (a)

1	is not greater than 125 percent of the amount
2	appropriated to carry out this section; and
3	"(B) after the end of a 14-day period be-
4	ginning on the date on which the Secretary sub-
5	mits to Congress—
6	"(i) notice of such additional contribu-

9	tribution; and
10	"(iii) the source of funds to be used
11	for such additional contribution.".
12	(b) Clerical Amendment.—The table of sections
13	at the beginning of subchapter I of chapter 169 of title
14	10, United States Code, is amended by inserting after the
15	item relating to section 2806 the following new item:
	"2806a. Contributions to improve the climate resilience of certain facilities of allies and partners of the United States.".
