Page 780, insert after line 7 the following:

1 **SEC. 1818. BRIEFING ON ACCESS OF MEMBERS OF NA-**
2 **TIONAL GUARD TO CHILD CARE SERVICES AT**
3 **MILITARY CHILD DEVELOPMENT CENTERS.**

4 (a) BRIEFING REQUIRED.—Not later than one year
5 after the date of the enactment of this Act, the Secretary
6 of Defense, in coordination with the Secretaries of the
7 Army and Air Force, shall submit to the Committees on
8 Armed Services of the Senate and House of Representa-
9 tives a briefing regarding the access of members of the
10 Army National Guard and the Air Force National Guard
11 to child care services at military child development centers.

12 (b) ELEMENTS.—The briefing under this section
13 shall include the following elements:

14 (1) The number of families in the Army Na-
15 tional Guard and the Air Force National Guard with
16 children under 12 years of age.

17 (2) The number of families in the Army Na-
18 tional Guard and the Air Force National Guard with
19 children under 12 years in which both parents are

1 members of either the Army National Guard or the
2 Air Force National Guard.

3 (3) The number of single parent households in
4 which the parent is a member of the Army National
5 Guard or the Air Force National Guard.

6 (4) The average number of days during the
7 year in which a member of the Army National
8 Guard or the Air Force National Guard who has a
9 child under 12 years of age is on active duty.

10 (5) The number of members of the Army Na-
11 tional Guard or the Air Force National Guard Num-
12 ber who have a child under 12 years of age who live
13 within the following distance of a military child de-
14 velopment center:

15 (A) 10 miles.

16 (B) 25 miles.

17 (C) 50 miles.

18 (D) Over 100 miles.

19 (6) The number of Army National Guard ar-
20 mories and Air Force National Guard armories with-
21 in the following distance of a military child develop-
22 ment center:

23 (A) 10 miles.

24 (B) 25 miles.

25 (C) 50 miles.

1 (D) Over 100 miles.

2 (7) The number of Army National Guard fami-
3 lies who have successfully obtained a voucher for
4 child care funding cost assistance though the
5 Childcare Aware and Upwards programs.

6 (8) The number of Air Force National Guard
7 families who have successfully obtained a voucher for
8 child care funding cost assistance though the
9 Childcare Aware and Upwards programs.

10 (9) The amount of funds currently spent on
11 vouchers under the Childcare Aware program for
12 Army National Guard families and Air Force Na-
13 tional Guard families, and the amount of funds cur-
14 rently spent on vouchers for Army National Guard
15 families and Air Force National Guard families
16 under the Upwards program.

17 (10) An overview of State laws that affect the
18 ability of military child development centers to pro-
19 vide 24-hour and overnight child care services.

20 (c) DEFINITION.—In this section, the term “military
21 child development center” has the meaning given such
22 term in section 1800 of title 10, United States Code.
