At the end of subtitle A of title XVII, add the following new section:

1	SEC. 17 GENOCIDE AND FORCED LABOR SANCTIONS.
2	(a) In General.—Not later than 60 days after the
3	date of the enactment of this Act, the Secretary of the
4	Treasury, in consultation with the Secretary of State and
5	the Attorney General, shall—
6	(1) determine whether any entity specified in
7	subsection (b)—
8	(A) is responsible for or complicit in, or
9	has directly or indirectly engaged in, genocide
10	and crimes against humanity, forced labor or
11	other serious human rights abuses against
12	Uyghurs, Kazakhs, Kyrgyz, or other predomi-
13	nantly Muslim ethnic groups in East Turkistan,
14	a captive nation designated by the People's Re-
15	public of China as the "Xinjiang Uyghur Au-
16	tonomous Region'; or
17	(B) meets the criteria for the imposition of
18	sanctions under—

1	(i) the Global Magnitsky Human
2	Rights Accountability Act (22 U.S.C.
3	10101 et seq.);
4	(ii) section 6 of the Uyghur Human
5	Rights Policy Act of 2020 (Public Law
6	116–145; 22 U.S.C. 6901 note);
7	(iii) section 105, 105A, 105B, or
8	105C of the Comprehensive Iran Sanc-
9	tions, Accountability, and Divestment Act
10	of 2010 (22 U.S.C. 8514, 8514a, 8514b,
11	and 8514c);
12	(iv) Executive Order 13818 (50
13	U.S.C. 1701 note; relating to blocking the
14	property of persons involved in serious
15	human rights abuse or corruption), as
16	amended on or after the date of the enact-
17	ment of this Act; or
18	(v) Executive Order 13553 (50 U.S.C.
19	1701 note; relating to blocking property of
20	certain persons with respect to serious
21	human rights abuses by the Government of
22	Iran and taking certain other actions), as
23	amended on or after the date of the enact-
24	ment of this Act;

1	(2) if the Secretary of the Treasury determines
2	under paragraph (1) that an entity is responsible for
3	or complicit in, or has directly or indirectly engaged
4	in, genocide, crimes against humanity, forced labor,
5	or serious human rights abuses described in sub-
6	paragraph (A) of that paragraph or meets the cri-
7	teria for the imposition of sanctions described in
8	subparagraph (B) of that paragraph, the Secretary
9	shall include the entity on the list of specially des-
10	ignated nationals and blocked persons maintained by
11	the Office of Foreign Assets Control; and
12	(3) submit to Congress a report on that deter-
13	mination that includes the reasons for the deter-
14	mination.
