AMENDMENT TO RULES COMM. PRINT 118–10 OFFERED BY MS. PRESSLEY OF MASSACHUSETTS

Add at the end of subtitle C of title XVIII the following:

1SEC. 1859. UPDATED REPORT ON THE ASSASSINATION OF2HAITIAN PRESIDENT JOVENEL MOÏSE RE-3QUIRED BY THE HAITI DEVELOPMENT, AC-4COUNTABILITY, AND INSTITUTIONAL TRANS-5PARENCY INITIATIVE ACT OF 2022.

6 (a) IN GENERAL.—Not later than 90 days after the 7 date of the enactment of this Act, the Secretary of State, in coordination with the Attorney General, the Secretary 8 9 of Homeland Security, and the Director of the Central In-10 telligence Agency, shall submit to the Committee on Foreign Relations of the Senate and the Committee on For-11 12 eign Affairs of the House of Representatives an update to the report on the July 7, 2021, assassination of former 13 14 President of Haiti Jovenel Moïse required under section 108(a) of the Haiti Development, Accountability, and In-15 16 stitutional Transparency Initiative Act, 2022 (division V 17 of Public Law 117–103).

18 (b) ELEMENTS.—The update to the report required19 under subsection (a) shall include the following:

1 (1) A detailed description of the events leading 2 up to the assassination of former President Jovenel 3 Moïse, and the subsequent investigation of the assas-4 sination, including a description and identification of 5 key dates and the names of foreign persons related 6 to the assassination and the investigation of the as-7 sassination.

8 (2) A description of United States support for
9 the efforts of Haitian authorities to investigate the
10 assassination of former President Jovenel Moïse.

(3) An assessment of the independence and capacity of Haitian authorities to investigate the assassination of former President Jovenel Moïse, including an analysis of significant advances and deficiencies of the investigation.

(4) A description of any threats and acts of intimidation against Haitian law enforcement and judicial authorities involved in the investigation of the
assassination of former President Jovenel Moïse, including the identification of foreign persons involved
in such threats and acts of intimidation.

(5) A description of any efforts to interfere in
or undermine the independence and integrity of the
investigation of the assassination of former President Jovenel Moïse.

(6) A description of whether any persons pre viously employed by or who served as a contractor
 or informant for the United States Government were
 involved in the assassination of former President
 Jovenel Moïse.

6 (7) A description and the identification of for-7 eign persons involved in the execution and planning 8 of the assassination of former President Jovenel 9 Moïse, and an assessment of the intentions of such 10 foreign persons.

(c) FORM OF REPORT.—The update to the report required under subsection (a) shall be submitted in unclassified form but may include a classified annex.

(d) PUBLICATION.—The Secretary of State shall post
on the public website of the Department of State the unclassified version of the update to the report required
under subsection (a) not later than 15 days after the date
on which such update to such report is submitted under
such subsection.

(e) BRIEFING REQUIREMENT.—The Secretary of
State, in coordination with the Attorney General, the Secretary of Homeland Security, and the Director of the Central Intelligence Agency, shall brief the Committee on Foreign Relations of the Senate and the Committee on Foreign Affairs of the House of Representatives on the con-
