1 **DIVISION I—DRINKING WATER**
2 **FUNDING FOR THE FUTURE**
3 **ACT OF 2021**

4 **SEC. 13001. SHORT TITLE.**

5 This division may be cited as the “Drinking Water
6 Funding for the Future Act of 2021”.

7 **SEC. 13002. EXTENSIONS OF AUTHORIZATIONS.**

8 (a) **COMMUNITY WATER SYSTEM RISK AND RESIL-**
9 **IENCE.**—Section 1433(g)(6) of the Safe Drinking Water
10 Act (42 U.S.C. 300i–2(g)(6)) is amended by striking “and
11 2021” and inserting “through 2026”.

12 (b) **TECHNICAL ASSISTANCE FOR INNOVATIVE**
13 **WATER TECHNOLOGIES.**—Section 1442(f)(2) of the Safe
14 Drinking Water Act (42 U.S.C. 300j–1(f)(2)) is amended
15 by striking “2021” and inserting “2026”.

16 (c) **GRANTS FOR STATE PROGRAMS.**—Section
17 1443(a)(7) of the Safe Drinking Water Act (42 U.S.C.
18 300j–2(a)(7)) is amended by striking “and 2021” and in-
19 serting “through 2026”.

1 (d) MONITORING PROGRAM FOR CERTAIN UNREGU-
2 LATED CONTAMINANTS.—Section 1445(a)(2)(H) of the
3 Safe Drinking Water Act (42 U.S.C. 300j–4(a)(2)(H)) is
4 amended by striking “2021” and inserting “2026”.

5 (e) CAPITALIZATION GRANTS TO STATES FOR STATE
6 DRINKING WATER TREATMENT REVOLVING LOAN
7 FUNDS.—Section 1452(m)(1)(C) of the Safe Drinking
8 Water Act (42 U.S.C. 300j–12(m)(1)(C)) is amended by
9 striking “for fiscal year 2021” and inserting “for each of
10 fiscal years 2021 through 2026”.

11 (f) SOURCE WATER PETITION PROGRAM.—Section
12 1454(e) of the Safe Drinking Water Act (42 U.S.C. 300j–
13 14(e)) is amended by striking “2021” and inserting
14 “2026”.

15 (g) ASSISTANCE FOR SMALL AND DISADVANTAGED
16 COMMUNITIES.—Section 1459A(k) of the Safe Drinking
17 Water Act (42 U.S.C. 300j–19a(k)) is amended by strik-
18 ing “2021” and inserting “2026”.

19 (h) REDUCING LEAD IN DRINKING WATER.—Section
20 1459B(d) of the Safe Drinking Water Act (42 U.S.C.
21 300j–19b(d)) is amended by striking “2021” and insert-
22 ing “2026”.

23 (i) VOLUNTARY SCHOOL AND CHILD CARE PROGRAM
24 LEAD TESTING GRANT PROGRAM.—Section 1464(d)(8) of
25 the Safe Drinking Water Act (42 U.S.C. 300j–24(d)(8))

1 is amended by striking “and 2021” and inserting
2 “through 2026”.

3 (j) DRINKING WATER FOUNTAIN REPLACEMENT FOR
4 SCHOOLS.—Section 1465(d) of the Safe Drinking Water
5 Act (42 U.S.C. 300j–25(d)) is amended by striking
6 “2021” and inserting “2026”.

7 (k) INDIAN RESERVATION DRINKING WATER PRO-
8 GRAM.—Section 2001(d) of America’s Water Infrastruc-
9 ture Act of 2018 (42 U.S.C. 300j–3c note) is amended
10 by striking “2022” and inserting “2026”.

11 (l) WATER INFRASTRUCTURE AND WORKFORCE IN-
12 VESTMENT.—Section 4304(b)(4) of America’s Water In-
13 frastructure Act of 2018 (42 U.S.C. 300j–19e) is amended
14 by striking “and 2020” and inserting “through 2026”.
