Add at the end of title LVIII of division E the following:

1 **SEC. \_\_\_\_ . REPORTING ON PREVIOUS FEDERAL BUREAU**  
2 **OF INVESTIGATION AND DEPARTMENT OF**  
3 **HOMELAND SECURITY REQUIREMENTS.**

4 (a) **REPORT REQUIRED.**—Not later than 60 days  
5 after the date of the enactment of this Act, the Director  
6 of the Federal Bureau of Investigation and the Secretary  
7 of Homeland Security, in consultation with the Office of  
8 the Director of National Intelligence, shall submit to the  
9 appropriate congressional committees a report on the  
10 processes needed to regularly report to Congress on do-  
11 mestic terrorism threats pursuant to Section 5602 of the  
12 National Defense Authorization Act for Fiscal Year 2020  
13 (Public Law 116-92).

14 (b) **DATA LIMITATIONS.**—In the event that data in-  
15 ternal to the Federal Bureau of Investigation and Depart-  
16 ment of Homeland Security on completed or attempted  
17 acts of domestic terrorism from January 1, 2009, to De-  
18 cember 31, 2014 is incomplete or inconsistent, the Direc-

1 tor of the Federal Bureau of Investigation and the Sec-  
2 retary of Homeland Security shall engage with State,  
3 local, Tribal, and territorial partners, academic institu-  
4 tions, non-profit organizations, and the private sector with  
5 expertise in domestic terrorism threats and acts to provide  
6 the most accurate and consistent information for the re-  
7 port required under subsection (a).

8 (c) GAO REPORT.— Not later than 180 days after  
9 the date of the enactment of this Act, the Government  
10 Accountability Office shall produce a report providing a  
11 full review of the Federal Bureau of Investigation’s, the  
12 Secretary of Homeland Security’s, and the Office of the  
13 Director of National Intelligence’s compliance with domes-  
14 tic terrorism transparency mechanisms required by Fed-  
15 eral law, including the National Defense Authorization Act  
16 for Fiscal Year 2020.

17 (d) DEFINITIONS.—In this section, the ter “appro-  
18 priate congressional committees” means—

19 (1) the Committee on Homeland Security and  
20 Governmental Affairs of the Senate;

21 (2) the Committee on the Judiciary of the Sen-  
22 ate;

23 (3) the Select Committee on Intelligence of the  
24 Senate;

- 1           (4) the Committee on Homeland Security of the
- 2           House of Representatives;
- 3           (5) the Committee on the Judiciary of the
- 4           House of Representatives; and
- 5           (6) the Permanent Select Committee on Intel-
- 6           ligence of the House of Representatives.
