

AMENDMENT TO
RULES COMMITTEE PRINT 118–10
OFFERED BY MR. RYAN OF NEW YORK

At the end of subtitle F of title X, add the following
new section:

1 **SEC. 10__ . REPORT ON ROLE OF ANTISEMITISM IN VIO-**
2 **LENT EXTREMIST MOVEMENTS AND RE-**
3 **LATED THREATS.**

4 (a) REPORT.—Not later than 180 days after the date
5 of the enactment of this Act, the Secretary of Defense
6 shall submit to the appropriate congressional committees
7 a report containing the results of a threat assessment on
8 violent antisemitism globally.

9 (b) ELEMENTS.—The report under subsection (a)
10 shall include the following:

11 (1) An overview of transnational violent extrem-
12 ist ideologies that include antisemitic components,
13 including Islamist extremism and racially and eth-
14 nically motivated violent extremism.

15 (2) A review of the violence committed on be-
16 half of, or motivated by, such ideologies, including—

17 (A) an identification of violent acts com-
18 mitted with explicit antisemitic sentiment; and

1 (B) an overview of propaganda facilitating
2 the spread of such ideologies, including an in-
3 depth assessment of the antisemitic components
4 of such propaganda.

5 (3) An assessment of the threat that the
6 antisemitic violence described in paragraphs (1) and
7 (2) poses to the United States homeland, citizens of
8 the United States residing abroad, and personnel of
9 the United States Government (including members
10 of the Armed Forces) and of how antisemitic violent
11 threats affect the interests and global standing of
12 the United States.

13 (c) FORM.—The report under subsection (a) shall be
14 submitted in unclassified form, but may include a classi-
15 fied annex.

16 (d) PUBLICATION.—Not later than 180 days after
17 the date of the enactment of this Act, the Secretary shall
18 publish on a publicly accessible website of the Department
19 of Defense the unclassified form of the report under sub-
20 section (a).

21 (e) LIMITATION.—The Secretary may not include in
22 the report under subsection (a), or any classified annex
23 accompanying such report, any personally identifiable in-
24 formation.

1 (f) APPROPRIATE CONGRESSIONAL COMMITTEES.—

2 In this section, the term “appropriate congressional com-
3 mittees” means—

4 (1) the Committee on Armed Services, the
5 Committee on Homeland Security, the Committee on
6 Foreign Affairs, and the Permanent Select Com-
7 mittee on Intelligence of the House of Representa-
8 tives; and

9 (2) the Committee on Armed Services, the
10 Committee on Homeland Security and Governmental
11 Affairs, the Committee on Foreign Relations, and
12 the Select Committee on Intelligence of the Senate.
