

AMENDMENT TO H.R. 4346, AS REPORTED
OFFERED BY MR. RYAN OF OHIO

Page 17, in the table between lines 8 and 9, strike the closing quotation marks before the period at the end.

Page 49, line 5, remove the quotation marks around “Section 1”.

At the end of the bill (before the short title) insert the following:

1 PLAQUE TO HONOR LAW ENFORCEMENT AGENCIES

2 RESPONDING TO ATTACK ON CAPITOL

3 SEC. 216. (a) SENSE OF CONGRESS.—It is the sense
4 of the Congress that the United States owes its deepest
5 gratitude to those United States Capitol Police and Wash-
6 ington, DC, Metropolitan Police Department officers, as
7 well as officers from multiple Federal, State, and local law
8 enforcement agencies, who valiantly protected the United
9 States Capitol, Members of Congress, and staff on Janu-
10 ary 6, 2021.

11 (b) PLAQUE.—The Architect of the Capitol shall ob-
12 tain an honorific plaque that commends the examples of
13 bravery and service-above-self demonstrated by officers of
14 the United States Capitol Police, the Metropolitan Police

1 Department of the District of Columbia, and the multiple
2 Federal, State, and local law enforcement agencies and
3 protective entities on the list compiled under subsection
4 (c) that joined alongside of them during the January 6,
5 2021 attack on the United States Capitol, and shall place
6 the plaque at a permanent location on the western front
7 of the United States Capitol.

8 (c) LIST OF AGENCIES.—

9 (1) COMPILATION.—The Committee on House
10 Administration of the House of Representatives and
11 the Committee on Rules and Administration of the
12 Senate shall jointly compile a list of Federal, State,
13 and local law enforcement agencies and protective
14 entities whose names should be included on the
15 plaque under subsection (b).

16 (2) SPECIFIC FEDERAL AGENCIES AND ENTI-
17 TIES INCLUDED.—The list compiled under para-
18 graph (1) shall include each of the following Federal
19 law enforcement agencies and protective entities:

20 (A) The United States Capitol Police.

21 (B) The National Guard Bureau, Depart-
22 ment of Defense.

23 (C) The Department of Homeland Secu-
24 rity.

1 (D) The Bureau of Alcohol, Tobacco, Fire-
2 arms and Explosives.

3 (E) The Federal Bureau of Investigation.

4 (F) The Pentagon Force Protection Agen-
5 cy, Department of Defense.

6 (G) The United States Secret Service.

7 (H) The United States Park Police.

8 (I) The United States Marshals Service.

9 (J) The Department of Health and Human
10 Services.

11 (3) SPECIFIC STATE AND LOCAL LAW AGENCIES
12 INCLUDED.—The list compiled under paragraph (1)
13 shall include each of the following State and local
14 law enforcement agencies:

15 (A) Metropolitan Police Department of the
16 District of Columbia.

17 (B) Metropolitan Washington Airports Au-
18 thority.

19 (C) Metro Transit Police Department,
20 Washington Metropolitan Area Transit Author-
21 ity.

22 (D) Virginia State Police.

23 (E) Fairfax County, Virginia, Police De-
24 partment.

1 (F) Prince William County, Virginia, Po-
2 lice Department.

3 (G) Arlington County, Virginia, Police De-
4 partment.

5 (H) Maryland Department of State Police.

6 (I) Prince George's County, Maryland, Po-
7 lice Department.

8 (J) Montgomery County, Maryland, De-
9 partment of Police.

10 (K) New Jersey State Police.

11 (4) CONFIRMATION.—The Committee on House
12 Administration of the House of Representatives and
13 the Committee on Rules and Administration of the
14 Senate shall work with the agencies and entities de-
15 scribed in paragraphs (2) and (3) to confirm the ac-
16 curacy of the list compiled under this section.

17 (d) PRESENTATION OF MATCHING PLAQUES TO
18 AGENCIES AND ENTITIES.—For each of the law enforce-
19 ment agencies and protective entities whose name is in-
20 cluded on the plaque under subsection (b), the Architect
21 of the Capitol shall obtain and present a plaque which
22 matches the plaque under subsection (b).

23 SEC. 217. (a) IN GENERAL.—The appropriate secu-
24 rity official of the House of Representatives and the Sen-
25 ate shall submit a report (in the appropriate format) to

1 the Committee on House Administration of the House of
2 Representatives, the Committee on Rules and Administra-
3 tion of the Senate, and the Committees on Appropriations
4 of the House of Representatives and Senate not later than
5 60 days after enactment of this Act on the procedures in
6 place for evacuating the Membership, staff, workforce, and
7 visitors of the Capitol, the House Office Buildings and the
8 Senate Office buildings.

9 (b) REQUIREMENTS OF REPORT.—The report ref-
10 erenced in subsection (a) shall include an assessment of
11 previous evacuations, plans for evacuations involving civil
12 disturbances, emergency management and emergency pre-
13 paredness training and existing emergency action response
14 plans and policies.

15 (c) CLASSIFICATION OF REPORT.—The report accom-
16 panying this section shall be submitted in unclassified
17 form but may be accompanied by a classified annex.
