Add at the end of division P the following new section:

1SEC. 160013. COLLECTION OF INFORMATION ON CERTAIN2THIRD PARTIES COLLECTING BALLOTS.

3 (a) COLLECTION OF INFORMATION.—Subtitle C of
4 title III of the Help America Vote Act of 2002, as added
5 by section 160003(a) and as amended by sections
6 160004(a), 160005(a), and 160007(c)(1), is further
7 amended—

8 (1) by redesignating sections 328 and 329 as
9 sections 329 and 330; and

10 (2) by inserting after section 327 the following11 new section:

12 "SEC. 328. COLLECTION OF INFORMATION ON CERTAIN
13 THIRD PARTIES COLLECTING BALLOTS.

"(a) COLLECTION.—If a State permits an individual
to collect and transmit to an election official a ballot in
an election for Federal office that was mailed to another
person, the State shall collect the following information
with respect to the individual:

9 (b) CLERICAL AMENDMENT.—The table of contents 10 of such Act, as added by section 160003 and as amended 11 by sections 160004, 160005, and 16007, is further 12 amended—

(1) by redesignating the items relating to sections 328 and 329 as relating to sections 329 and
330; and

16 (2) by inserting after the item relating to sec-17 tion 327 the following new item:

"Sec. 328. Collection of information on certain third parties collecting ballots.".

(c) EFFECTIVE DATE.—The amendments made by
this section shall apply with respect to the regularly scheduled general election for Federal office held in November
2020 and each succeeding election for Federal office.
