## AMENDMENT TO H.R. 6800 OFFERED BY MR. RODNEY DAVIS OF ILLINOIS

Add at the end of division P the following new section:

1	SEC. 160013. PROHIBITION ON PAYMENTS TO STATES AL-
2	LOWING COLLECTION AND TRANSMISSION
3	OF BALLOTS BY CERTAIN THIRD PARTIES.
4	(a) In General.—Subtitle D of title II of the Help
5	America Vote Act of 2002 (52 U.S.C. 21001 et seq.), as
6	amended by section 160009(a) and section 160010(a), is
7	further amended by adding at the end the following new
8	part:
9	"PART 9—PROHIBITION ON PAYMENTS TO
10	STATES ALLOWING COLLECTION AND
11	TRANSMISSION OF BALLOTS BY CERTAIN
12	THIRD PARTIES
13	"SEC. 299. ELIGIBILITY FOR PAYMENTS OF STATES ALLOW-
14	ING COLLECTION AND TRANSMISSION OF
15	BALLOTS BY CERTAIN THIRD PARTIES.
16	"(a) In General.—A State is not eligible to receive
17	funds under this Act unless the State has in effect a law
18	that prohibits an individual from the knowing collection
19	and transmission of a ballot in an election for Federal of-

1	fice that was mailed to another person, other than an indi-
2	vidual described as follows:
3	"(1) An election official while engaged in offi-
4	cial duties as authorized by law.
5	"(2) An employee of the United States Postal
6	Service while engaged in official duties as authorized
7	by law.
8	"(3) Any other individual who is allowed by law
9	to collect and transmit United States mail, while en-
10	gaged in official duties as authorized by law.
11	"(4) A family member, household member, or
12	caregiver of the person to whom the ballot was
13	mailed.
14	"(b) Definitions.—For purposes of this section,
15	with respect to a person to whom the ballot was mailed:
16	"(1) The term 'caregiver' means an individual
17	who provides medical or health care assistance to
18	such person in a residence, nursing care institution,
19	hospice facility, assisted living center, assisted living
20	facility, assisted living home, residential care institu-
21	tion, adult day health care facility, or adult foster
22	care home.
23	"(2) The term 'family member' means an indi-
24	vidual who is related to such person by blood, mar-
25	riage, adoption or legal guardianship.

1	"(3) The term 'household member' means an
2	individual who resides at the same residence as such
3	person.".
1	(b) CLERICAL AMENDMENT.—The table of contents
5	of such Act, as amended by section 160009(b) and section
6	160010(b), is further amended by adding at the end of
7	the items relating to subtitle D of title II the following:
	"Part 9-Prohibition on Payments to States Allowing Collection and Transmission of Ballots by Certain Third Parties
	"Sec. 299. Eligibility for payments of States allowing collection and transmission of ballots by certain third parties.".
