## AMENDMENT TO RULES COMMITTEE PRINT 11810

## OFFERED BY MR. SABLAN OF NORTHERN MARIANA ISLANDS

At the end of subtitle C of title XVIII, add the following:

1	SEC. 18 INCLUSION OF COMMONWEALTH OF THE
2	NORTHERN MARIANA ISLANDS AND AMER-
3	ICAN SAMOA IN THE WAGNER-PEYSER ACT.
4	The Wagner-Peyser Act (29 U.S.C. 49 et seq.) is
5	amended—
6	(1) in section 2(5) (29 U.S.C. 49a(5)), by in-
7	serting "the Commonwealth of the Northern Mar-
8	iana Islands, American Samoa," after "Guam,";
9	(2) in section 5(b)(1) (29 U.S.C. 49d(b)(1)), by
10	inserting "the Commonwealth of the Northern Mar-
11	iana Islands, and American Samoa," after "Guam,";
12	(3) in section 6(a) (29 U.S.C. 49e(a))—
13	(A) by inserting ", the Commonwealth of
14	the Northern Mariana Islands, and American
15	Samoa" after "except for Guam";
16	(B) by striking "allot to Guam" and in-
17	serting the following: "allot to—

1	"(1) Guam";
2	(C) by striking the period at the end and
3	inserting a semicolon; and
4	(D) by adding at the end the following:
5	"(2) the Commonwealth of the Northern Mar-
6	iana Islands an amount which, in relation to the
7	total amount available for the fiscal year, is equal to
8	the allotment percentage that Guam received of
9	amounts available under this Act in fiscal year 1983;
10	and
11	"(3) American Samoa an amount which, in re-
12	lation to the total amount available for the fiscal
13	year, is equal to the allotment percentage that Guam
14	received of amounts available under this Act in fiscal
15	year 1983.''; and
16	(4) in section 6(b) (29 U.S.C. 49e(b))—
17	(A) in paragraph (1)—
18	(i) in the matter preceding subpara-
19	graph (A), by striking "paragraphs (2),
20	(3), and (4) of this subsection" and insert-
21	ing "paragraph (2) of this subsection";
22	and
23	(ii) in the matter following subpara-
24	graph (B), by inserting ", the Common-
25	wealth of the Northern Mariana Islands.

1	American Samoa," after "does not include
2	Guam''; and
3	(B) by adding at the end the following:
4	"(2)(A) No State may receive an allotment
5	under paragraph (1) for a fiscal year that is less
6	than the allotment that the State received under
7	paragraph (1) for the fiscal year preceding the first
8	fiscal year for which the Commonwealth of the
9	Northern Mariana Islands and American Samoa re-
10	ceive an allotment under subsection $(a)(1)$ .
11	"(B) If for any fiscal year the amount available
12	for allotment under this subsection is insufficient to
13	satisfy the provisions of subparagraph (A) the Sec-
14	retary shall ratably reduce the allotments to all
15	States for such fiscal year.".
