At the end of subtitle F of title VIII, insert the following new section:

2 **FOR CERTAIN SMALL BUSINESS CONCERNS.**

3 (a) **SOCIALLY AND ECONOMICALLY DISADVANTAGED**  
4 **SMALL BUSINESS CONCERNS.**—Section 8(a)(1)(D)(i)(II)  
5 of the Small Business Act (15 U.S.C. 637(a)(1)(D)(i)(II))  
6 is amended—

7 (1) by striking “\$7,000,000” and inserting  
8 “\$10,000,000”; and

9 (2) by striking “\$3,000,000” and inserting  
10 “\$8,000,000”.

11 (b) **CERTAIN SMALL BUSINESS CONCERNS OWNED**  
12 **AND CONTROLLED BY WOMEN.**—Section 8(m) of the  
13 Small Business Act (15 U.S.C. 637(m)) is amended—

14 (1) in paragraph (7)(B)—

15 (A) in clause (i), by striking “\$7,000,000”  
16 and inserting “\$10,000,000”; and

17 (B) in clause (ii), by striking “\$4,000,000”  
18 and inserting “\$8,000,000”; and

1 (2) in paragraph (8)(B)—

2 (A) in clause (i), by striking “\$7,000,000”

3 and inserting “\$10,000,000”; and

4 (B) in clause (ii), by striking “\$4,000,000”

5 and inserting “\$8,000,000”.

6 (c) QUALIFIED HUBZONE SMALL BUSINESS CON-

7 CERNS.—Section 31(c)(2)(A)(ii) of the Small Business

8 Act (15 U.S.C. 657a(c)(2)(A)(ii)) is amended—

9 (1) in subclause (I), by striking “\$7,000,000”

10 and inserting “\$10,000,000”; and

11 (2) in subclause (II), by striking “\$3,000,000”

12 and inserting “\$8,000,000”.

13 (d) SMALL BUSINESS CONCERNS OWNED AND CON-

14 TROLLED BY SERVICE-DISABLED VETERANS.—Section

15 36(c)(2) of the Small Business Act (15 U.S.C. 657f) is

16 amended—

17 (1) in subparagraph (A), by striking

18 “\$7,000,000” and inserting “\$10,000,000”; and

19 (2) in subparagraph (B), by striking

20 “\$3,000,000” and inserting “\$8,000,000”.

21 (e) CERTAIN VETERAN-OWNED CONCERNS.—Section

22 8127(c) of title 38, United States Code, is amended by

23 striking “\$5,000,000” and inserting “the dollar thresholds

24 under section 36(c)(2)(A) of the Small Business Act”.
