

AMENDMENT TO
RULES COMMITTEE PRINT 117-13
OFFERED BY MS. SCHAKOWSKY OF ILLINOIS

Add at the end of subtitle C of title XIII the following new section:

1 **SEC. ____ . PROHIBITION ON COMMERCIAL EXPORT OF**
2 **COVERED DEFENSE ARTICLES AND SERVICES**
3 **AND COVERED MUNITIONS ITEMS TO THE**
4 **HONDURAN POLICE OR MILITARY.**

5 (a) **IN GENERAL.**—Not later than 30 days after the
6 date of the enactment of this Act, the President shall pro-
7 hibit the issuance of licenses to export covered defense ar-
8 ticles and services and covered munitions items to the po-
9 lice or military of the Republic of Honduras.

10 (b) **TERMINATION.**—The prohibition under sub-
11 section (a) shall terminate on the date on which the Presi-
12 dent determines and reports to the appropriate congres-
13 sional committees that the police or military of the Repub-
14 lic of Honduras have not engaged in gross violations dur-
15 ing the one-year period ending on the date of such deter-
16 mination.

17 (c) **WAIVER.**—The prohibition under subsection (a)
18 shall not apply to the issuance of a license with respect

1 to which the President submits to the appropriate congres-
2 sional committees a written certification that the exports
3 to be covered by such license are important to the national
4 interests and foreign policy goals of the United States, in-
5 cluding a description of the manner in which such exports
6 will promote such interests and goals.

7 (d) DEFINITIONS.—In this section:

8 (1) APPROPRIATE CONGRESSIONAL COMMIT-
9 TEES.—The term “appropriate congressional com-
10 mittees” means—

11 (A) the Committee on Foreign Relations
12 and the Committee on Appropriations of the
13 Senate; and

14 (B) the Committee on Foreign Affairs and
15 the Committee on Appropriations of the House
16 of Representatives.

17 (2) COVERED DEFENSE ARTICLES AND SERV-
18 ICES.—The term “covered defense articles and serv-
19 ices” means defense articles and defense services
20 designated by the President under section 38(a)(1)
21 of the Arms Export Control Act (22 U.S.C.
22 2778(a)(1)).

23 (3) COVERED MUNITIONS ITEMS.—The term
24 “covered munitions items” means tear gas, pepper
25 spray, rubber bullets, foam rounds, bean bag rounds,

1 pepper balls, water cannons, handcuffs, shackles,
2 stun guns, tasers, semi-automatic firearms, and
3 their associated munitions not included in the defini-
4 tion under paragraph (2).
