1SEC. 1706. INTERAGENCY REPORT ON EXTREMIST ACTIV-2ITY.

3 (a) IN GENERAL.—Not later than 180 days after the 4 date of enactment of this Act, and every 6 months there-5 after, the Director of the Federal Bureau of Investigation, the Secretary of Homeland Security, and the Secretary of 6 Defense shall publish a report that analyzes and sets out 7 strategies to combat White supremacist and neo-Nazi in-8 9 filtration of the uniformed services and Federal law enforcement agencies. 10

11 (b) REPORT.—

(1) IN GENERAL.—The Director of the Federal
Bureau of Investigation, the Secretary of Homeland
Security, and the Secretary of Defense shall submit
a joint report detailing Executive-wide plans described in subsection (a) that includes—

1	(A) the number of individuals discharged
2	from the uniformed services due to incidents re-
3	lated to White supremacy and neo-Nazi activity;
4	(B) for each instance included in the total

6	the circumstances that led to the separation of

4	(2) TRANSMISSION.—The Director of the Fed-

6	only if necessary; and
7	(B) in the case of the unclassified portion
8	of the report, posted on the public website of
9	the Department of Defense, the Department of
10	Homeland Security, the Department of Justice,
11	and the Federal Bureau of Investigation.
