

AMENDMENT TO RULES COMMITTEE PRINT 119-8
OFFERED BY MR. SCHWEIKERT OF ARIZONA

At the end of subtitle B of title XVII, insert the following new section:

1 **SEC. 17___ PUBLIC DISCLOSURE OF VEHICLE AND AIR-**
2 **CRAFT MANIFEST INFORMATION.**

3 (a) IN GENERAL.—Section 431 of the Tariff Act of
4 1930 (19 U.S.C. 1431) is amended—

5 (1) by amending subsection (a) to read as fol-
6 lows:

7 “(a) IN GENERAL.—Each of the following shall have
8 a manifest that complies with the requirements prescribed
9 under subsection (d):

10 “(1) Every vessel required to make entry under
11 section 434 or obtain clearance under section 60105
12 of title 46, United States Code.

13 “(2) Every vehicle and aircraft arriving in the
14 United States that was required by US Customs and
15 Border Protection to have a manifest before the date
16 of the enactment of the National Defense Authoriza-
17 tion Act for Fiscal Year 2026.”; and

18 (2) in subsection (c)(1)—

1 (A) in the matter preceding subparagraph
2 (A), by striking “subparagraph (2)” and all
3 that follows through “public disclosure” and in-
4 serting “paragraph (2), when included in a ves-
5 sel, vehicle, or aircraft manifest, the following
6 information shall be available for public disclo-
7 sure”;

8 (B) in subparagraph (D), by striking “ves-
9 sel, aircraft, or carrier” and inserting “vessel,
10 vehicle, or aircraft”;

11 (C) in subparagraph (E), by striking “or
12 airport of loading” and inserting “, airport, or
13 other point of loading”; and

14 (D) in subparagraph (F), by striking “or
15 airport of discharge” and inserting “, airport,
16 or other point of discharge”.

17 (b) BOND REQUIREMENT FOR TRUCKS.—Section
18 431(d)(1) of the Tariff Act of 1930 (19 U.S.C.
19 1431(d)(1)) is amended—

20 (1) in subparagraph (C), by striking “; and”
21 and inserting a semicolon;

22 (2) in subparagraph (D), by striking the period
23 at the end and inserting “; and”; and

24 (3) by adding at the end the following:

1 “(E) require each vehicle arriving in the
2 United States and required under subsection
3 (a) to have a manifest to post a bond to ensure
4 compliance with that requirement.”.

5 (c) DEFINITION OF AIRCRAFT.—Section 401 of the
6 Tariff Act of 1930 (19 U.S.C. 1401) is amended by add-
7 ing at the end the following:

8 “(u) AIRCRAFT.—

9 “(1) IN GENERAL.—Except as provided by
10 paragraph (2), the term ‘aircraft’ has the meaning
11 given that term in section 40102 of title 49, United
12 States Code.

13 “(2) EXCLUSION.—The term ‘aircraft’ does not
14 include a public aircraft (as defined in section 40102
15 of title 49, United States Code).”.

16 (d) APPLICABILITY.—The amendments made by sub-
17 sections (a) and (b) shall apply with respect to each vessel,
18 vehicle, and aircraft arriving in or departing from the
19 United States on or after the date that is 120 days after
20 the date of the enactment of this section.
