

**AMENDMENT TO**  
**RULES COMMITTEE PRINT 117-2**  
**OFFERED BY MR. O'HALLERAN OF ARIZONA**

At the end of the bill, insert the following new title:

1 **TITLE IX—SUNSET CRATER VOL-**  
2 **CANO NATIONAL MONUMENT**  
3 **BOUNDARY ADJUSTMENT**

4 **SEC. 901. SHORT TITLE.**

5 This title may be cited as the “Sunset Crater Volcano  
6 National Monument Boundary Adjustment Act”.

7 **SEC. 902. DEFINITIONS.**

8 In this title:

9 (1) FEDERAL LAND.—The term “Federal land”  
10 means the approximately 97.71 acres of Forest  
11 Service land identified as “Proposed transfer from  
12 USDA Forest Service to National Park Service” on  
13 the Map.

14 (2) MAP.—The term “Map” means the map en-  
15 titled “Sunset Crater Volcano National Monument  
16 Draft Proposed Boundary Adjustment”, numbered  
17 039/80,053d, and dated March 2020.

18 (3) MONUMENT.—The term “Monument”  
19 means the Sunset Crater Volcano National Monu-

1           ment established by Presidential Proclamation 1911  
2           (54 U.S.C. 320301 note; 46 Stat. 3023) and reded-  
3           signed by section 15 of the Smith River National  
4           Recreation Area Act (Public Law 101–612; 104  
5           Stat. 3222).

6           (4) SECRETARY.—The term “Secretary” means  
7           the Secretary of the Interior, acting through the Di-  
8           rector of the National Park Service.

9   **SEC. 903. SUNSET CRATER VOLCANO NATIONAL MONU-**  
10                                   **MENT BOUNDARY MODIFICATION.**

11           (a) BOUNDARY MODIFICATION.—The boundary of  
12           the Monument is modified to include the Federal land.

13           (b) MAP AVAILABILITY.—The Map shall be on file  
14           and available for inspection in the appropriate offices of  
15           the National Park Service.

16           (c) TRANSFER OF ADMINISTRATIVE JURISDICTION  
17           TO NATIONAL PARK SERVICE.—Administrative jurisdic-  
18           tion over the Federal land is transferred from the Forest  
19           Service to the National Park Service.

20           (d) ADMINISTRATION.—Subject to valid existing  
21           rights, the Secretary shall administer the Federal land  
22           added to the Monument under subsection (a)—

23                           (1) as part of the Monument; and

1                   (2) in accordance with applicable laws (includ-  
2                   ing regulations).
