Page 1348, after line 23, insert the following:

1 **SEC. 5806. TRANSFER OF NOAA PROPERTY IN NORFOLK,**
2 **VIRGINIA.**

3 (a) IN GENERAL.—The Act entitled, “An Act to au-
4 thorize the Secretary of Commerce to sell or exchange cer-
5 tain National Oceanic and Atmospheric Administration
6 property located in Norfolk, Virginia, and for other pur-
7 poses”, enacted on October 13, 2008 (P.L. 110-393; 122
8 Stat. 4203), is amended by striking the heading and sub-
9 sections (a), (b), (c), and (d) of section 1 and inserting
10 the following:

11 **“SECTION 1. TRANSFER OF NOAA PROPERTY IN NORFOLK,**
12 **VIRGINIA.**

13 “(a) IN GENERAL.—The Secretary of Commerce
14 shall transfer without consideration all right, title, and in-
15 terest of the United States in and to the property de-
16 scribed in subsection (b) to the City of Norfolk, Virginia,
17 not later than the earlier of—

18 “(1) the date on which the Secretary of Com-
19 merce has transferred all of the employees of the

1 National Oceanic and Atmospheric Administration
2 (in this section referred to as ‘NOAA’) from its fa-
3 cilities at the property described in subsection (b); or

4 “(2) 5 years after the date of the enactment of
5 this Act.

6 “(b) PROPERTY DESCRIBED.—The property de-
7 scribed in this subsection is—

8 “(1) the real property under the administrative
9 jurisdiction of the NOAA, including land and im-
10 provements thereon, located at 538 Front Street,
11 Norfolk, Virginia, consisting of approximately 3.78
12 acres; and

13 “(2) the real property under the administrative
14 jurisdiction of the NOAA, including land and im-
15 provements thereon, located at 439 W. York Street,
16 Norfolk, Virginia, consisting of approximately
17 2.5231 acres.

18 “(c) SURVEY.—The exact acreage and legal descrip-
19 tion of the property described in subsection (b) shall be
20 determined by a survey or surveys satisfactory to the Sec-
21 retary.

22 “(d) COMPLIANCE WITH COMPREHENSIVE ENVIRON-
23 MENTAL RESPONSE, COMPENSATION, AND LIABILITY ACT
24 OF 1980.—In carrying out this section, the Secretary shall
25 comply with section 120(h) of the Comprehensive Environ-

1 mental Response, Compensation, and Liability Act of
2 1980 (42 U.S.C. 9620(h)).”.

3 (b) CONFORMING AMENDMENT.—Subsection (e) of
4 section 1 of such Act (122 Stat. 4204) is amended by
5 striking the first sentence.
