

AMENDMENT TO RULES COMMITTEE PRINT 116-

OFFERED BY MS. SHALALA OF FLORIDA

At the end of subtitle E of title XVII, add the following new section:

1 **SEC. 17___ . RESTRICTIONS ON CONFUCIUS INSTITUTES.**

2 (a) RESTRICTIONS ON CONFUCIUS INSTITUTES.—An
3 institution of higher education or other postsecondary edu-
4 cational institution (referred to in this section as an “insti-
5 tution”) shall not be eligible to receive Federal funds from
6 the Department of Defense, other than educational assist-
7 ance funds that are provided directly to students, unless—

8 (1) the institution submits any contract or
9 agreement between the institution and a Confucius
10 Institute to the National Academies of Sciences, En-
11 gineering, and Medicine; and

12 (2) the National Academies of Sciences, Engi-
13 neering, and Medicine issues a written determination
14 that the contract or agreement includes clear provi-
15 sions that—

16 (A) protect academic freedom at the insti-
17 tution;

1 (B) prohibit the application of any foreign
2 law on any campus of the institution; and

3 (C) grant full managerial authority of the
4 Confucius Institute to the institution, including
5 full control over what is being taught, the ac-
6 tivities carried out, the research grants that are
7 made, and who is employed at the Confucius
8 Institute.

9 (b) CONFUCIUS INSTITUTE DEFINED.—In this sec-
10 tion, the term “Confucius Institute” means a cultural in-
11 stitute directly or indirectly funded by the Government of
12 the People’s Republic of China.

13 (c) FUNDING.—

14 (1) INCREASE.—Notwithstanding the amounts
15 set forth in the funding tables in division D, the
16 amount authorized to be appropriated in section 201
17 for research, development, test, and evaluation, as
18 specified in the corresponding funding table in sec-
19 tion 4201, for research, development, test, and eval-
20 uation, Defense-wide, basic research, basic research
21 initiatives (PE 0601110D8Z), line 003 is hereby in-
22 creased by \$1,000,000 (to be used in support of the
23 National Academies of Sciences, Engineering, and
24 Medicine assessments under subsection (a)).

1 (2) OFFSET.—Notwithstanding the amounts set
2 forth in the funding tables in division D, the amount
3 authorized to be appropriated in section 301 for op-
4 eration and maintenance as specified in the cor-
5 responding funding table in section 4301, for oper-
6 ation and maintenance, Defense-wide, admin &
7 servicewide activities, Defense Information Systems
8 Agency, line 280 is hereby reduced by \$1,000,000.
