At the end of subtitle C of title VII, add the following new section:

SEC. 7 REGISTRY OF INDIVIDUALS EXPOSED TO PER-
AND POLYFLUOROALKYL SUBSTANCES ON
MILITARY INSTALLATIONS.
(a) ESTABLISHMENT OF REGISTRY.—
(1) IN GENERAL.—Not later than one year
after the date of the enactment of this Act, the Sec-
retary of Veterans Affairs shall—
(A) establish and maintain a registry for
eligible individuals who may have been exposed
to per- and polyfluoroalkyl substances (in this
section referred to as "PFAS") due to the envi-
ronmental release of aqueous film-forming foam
(in this section referred to as "AFFF") on mili-
tary installations to meet the requirements of
military specification MIL–F–24385F;
(B) include any information in such reg-

istry that the Secretary of Veterans Affairs de-

2	health effects of the exposure of members of the

4	(C) develop a public information campaign
5	to inform eligible individuals about the registry,
6	including how to register and the benefits of
7	registering; and
8	(D) periodically notify eligible individuals
9	of significant developments in the study and
10	treatment of conditions associated with expo-
11	sure to PFAS.
12	(2) COORDINATION.—The Secretary of Vet-
13	erans Affairs shall coordinate with the Secretary of
14	Defense in carrying out paragraph (1).
15	(b) Reports.—
16	(1) INITIAL REPORT.—Not later than two years
17	after the date on which the registry under subsection
18	(a) is established, the Secretary of Veterans Affairs
19	shall submit to Congress an initial report containing

21	(A) An assessment of the effectiveness of
22	actions taken by the Secretary of Veterans Af-

25	SURES TO BE INCLUDED.—Not later than five years after

the date of the enactment of this Act, and every five years 1 2 thereafter, the Secretary of Veterans Affairs, in consultation with the Secretary of Defense and the Administrator 3 4 of the Environmental Protection Agency, shall submit to 5 Congress recommendations for additional chemicals with 6 respect to which individuals exposed to such chemicals 7 should be included in the registry established under sub-8 section (a).

9 (d) ELIGIBLE INDIVIDUAL DEFINED.—In this sec-10 tion, the term "eligible individual" means any individual 11 who, on or after November 21, 1969, served or is serving 12 in the Armed Forces at a military installation where 13 AFFF was used or at another location of the Department 14 of Defense where AFFF was used.
