

AMENDMENT TO RULES COMMITTEE PRINT 119-8
OFFERED BY MS. SHERRILL OF NEW JERSEY

At the end of subtitle B of title II, add the following
new section:

1 **SEC. 2 ____ . LIMITATION ON AVAILABILITY OF FUNDS FOR**
2 **REALIGNMENT OF THE RESEARCH, DEVELOP-**
3 **MENT, TEST, AND EVALUATION FUNCTION**
4 **FOR ARMY AMMUNITION.**

5 (a) LIMITATION.—None of the funds authorized to
6 be appropriated by this Act or otherwise made available
7 for fiscal year 2026 for the Department of Defense may
8 be obligated or expended to realign the research, develop-
9 ment, test, and evaluation function for Army ammunition
10 away from the current Joint Program Executive Office
11 Armaments and Ammunition or Joint Capabilities Port-
12 folio Executive Ammunition construct until a period of
13 180 days has elapsed following the date on which the re-
14 port required under subsection (b) is submitted to the con-
15 gressional defense committees.

16 (b) REPORT REQUIRED.—Not later than November
17 1, 2026, the Secretary of the Army shall submit to the
18 congressional defense committees a report that includes

1 the following with respect to the proposed realignment of
2 functions described in subsection (a):

3 (1) An explanation of whether Army personnel,
4 including contractors, would be required to relocate
5 to a new location and if so an estimate of how many
6 personnel would relocate and to what locations.

7 (2) An explanation of whether the Army expects
8 to build new facilities and infrastructure at new lo-
9 cations to accomplish the research, development,
10 test, and evaluation function for Army ammunition
11 and, if so, identification of—

12 (A) what new facilities and infrastructure
13 would have to be constructed; and

14 (B) where such facilities and infrastructure
15 would be constructed.

16 (3) A detailed estimate of the costs of relo-
17 cating personnel and equipment and constructing
18 new facilities and infrastructure.

19 (4) A detailed explanation of the efficiencies, if
20 any, that the Army expects to realize by realigning
21 the research, development, test, and evaluation func-
22 tion for Army ammunition to Capabilities Portfolio
23 Executive Fires.

24 (5) In consultation with the with the Secretary
25 of the Navy and the Secretary of the Air Force, a

1 determination as to whether realigning the research,
2 development, test, and evaluation function for Army
3 ammunition to Capabilities Portfolio Executive Fires
4 will hinder or impede the joint construct that Joint
5 Program Executive Office Armaments and Ammuni-
6 tion has traditionally maintained with the Navy, Ma-
7 rine Corps, and Air Force.
