

**AMENDMENT TO RULES**  
**COMMITTEE PRINT 119–8**  
**OFFERED BY MR. SHREVE OF INDIANA**

Page 927, after line 16, insert the following new section:

1 **SEC. 17\_\_\_\_. STRATEGY TO COUNTER IRANIAN AND**  
2 **HEZBOLLAH INFLUENCE OPERATIONS IN**  
3 **LATIN AMERICA.**

4 (a) STRATEGY REQUIRED.—Not later than 180 days  
5 after the enactment of this Act, the Secretary of Defense,  
6 in consultation with the Secretary of State and the Direc-  
7 tor of National Intelligence, shall submit to the appro-  
8 priate congressional committees a comprehensive strategy  
9 to counter Iran’s and Hezbollah’s propaganda, missionary  
10 networks, and influence operations in Latin America.

11 (b) CONTENTS OF THE STRATEGY.—The strategy re-  
12 quired under subsection (a) shall include the following:

13 (1) Measures to address the proliferation of  
14 Iranian cultural centers in Latin America that pro-  
15 mote Iranian ideology, including diplomatic efforts  
16 to limit their operations, sanctions on affiliated enti-  
17 ties, and public diplomacy to expose their activities.

1           (2) Actions to restrict the travel and activities  
2           of Iranian emissaries, including diplomats, cultural  
3           attaches, and other agents who facilitate propa-  
4           ganda, radicalization, and terror-supporting net-  
5           works in Latin America, through visa denials, sanc-  
6           tions, or other travel restrictions.

7           (3) Initiatives to strengthen the capacity of  
8           U.S. intelligence agencies to identify, monitor, and  
9           disrupt Iran's and Hezbollah's networks, including  
10          their cooperation academic institutions and non-gov-  
11          ernmental organizations in Latin America.

12          (4) A framework for taking actions, similar to  
13          those implemented against Al-Manar and Press TV,  
14          to disrupt Iran's HispanTV and Hezbollah's Al  
15          Mayadeen Espanol platforms, including sanctions,  
16          designations, and cooperation with regional partners  
17          to limit their broadcasting reach and digital pres-  
18          ence.

19          (5) A plan to address Iran's Al Mustafa Inter-  
20          national University network and its affiliated enti-  
21          ties, including their designations as foreign terrorist  
22          organizations or specially designated global terror-  
23          ists, as appropriate, due to their role in  
24          radicalization and recruitment for Iran's ideological  
25          and terrorist objectives.

1 (c) FORM.—The strategy required in subsection (a)  
2 shall be transmitted in unclassified form and may include  
3 a classified annex.

4 (d) APPROPRIATE CONGRESSIONAL COMMITTEES  
5 DEFINED.—In this section, the term “appropriate con-  
6 gressional committees” means—

7 (1) the Committees on Armed Services of the  
8 Senate and the House of Representatives;

9 (2) the Committee on Foreign Affairs of the  
10 House of Representatives;

11 (3) the Committee on Foreign Relations of the  
12 Senate;

13 (4) the Permanent Select Committee on Intel-  
14 ligence of the House of Representatives; and

15 (5) the Select Committee on Intelligence of the  
16 Senate.
