Page 872, after line 9, insert the following new section (and conform the table of contents accordingly):

## 1 SEC. 1273. REPORT ON MEXICAN SECURITY FORCES.

- 2 (a) Report.—Not later than 90 days after enact-
- 3 ment of this act, the Secretary of Defense and the Sec-
- 4 retary of State, in coordination with other appropriate of-
- 5 ficials, shall jointly submit to the appropriate congres-
- 6 sional committees a report containing a comprehensive as-
- 7 sessment of ongoing support and a strategy for future co-
- 8 operation between the United States government and the
- 9 Mexican security forces including the Mexican National
- 10 Guard, federal, state, and municipal law enforcement.
- 11 (b) MATTERS TO BE INCLUDED.—The report under
- 12 subsection (a) shall include, at minimum, the following:
- 13 (1) Department of Defense and Department of
- 14 State strategy and timeline for assistance to Mexi-
- can security forces, including detailed areas of as-
- sistance and a plan to align the strategy with Mexi-
- can government priorities; .

1	(2) Description of the transfer of U.Ssup-
2	ported equipment from the Federal Police and
3	armed forces to the National Guard, if any, and any
4	resources originally provided for the Federal Police
5	and armed forces that are now in use by the Na-
6	tional Guard.
7	(3) Dollar amounts of any assistance provided
8	or to be provided to each of the Mexican security
9	forces, and any defense articles, training, and other
10	services provided or to be provided to each of the
11	Mexican security forces.
12	(4) Department of Defense and Department of
13	State plans for all U.S. training for Mexican secu-
14	rity forces, including training in human rights, prop-
15	er use of force, de-escalation, investigation and evi-
16	dence-gathering, community relations, and anti-cor-
17	ruption.
18	(5) An assessment of the National Guard's ad-
19	herence to human rights standards, including the
20	adoption of measures to ensure accountability for
21	human rights violations and the development of a
22	human rights training curriculum.
23	(6) Department of Defense and Department of
24	State plans to support external monitoring and
25	strengthen internal control mechanisms within each

1	of the Mexican security forces including the Mexican
2	National Guard, federal, state, and municipal law
3	enforcement, including the internal affairs unit.
4	(7) Information on Mexico's security budget
5	and contributions to strengthening security coopera-
6	tion with the United States; and (8) Information on
7	security assistance Mexico may be receiving from
8	other countries.
9	(c) FORM.—The report required under subsection (a)
10	may be submitted in classified form with an unclassified
11	summary.
12	(d) Appropriate Congressional Committees.—
13	The term "appropriate congressional committees" means
14	the Committee on Foreign Affairs and the Armed Services
15	Committee of the House of Representatives and the Com-
16	mittee on Foreign Relations and the Armed Services Com-
17	mittee of the Senate.
