12	"(B) A veteran who died from amyotrophic lateral
13	sclerosis shall be treated as a veteran described in sub-
14	paragraph (A) without regard for how long the veteran
15	had such disease prior to death.
16	"(C) For purposes of the payment of compensation
17	under this subsection by reason of the death of veteran
18	described in subparagraph (B), the term 'surviving spouse'

means a person who was married to the veteran for a con tinuous period of eight years or longer prior to the death
 of the veteran.".

4 (2) APPLICABILITY.—Subparagraphs (B) and
5 (C) of section 1311(a)(2) of title 38, United States
6 Code, as added by paragraph (1), shall apply to a
7 veteran who dies from amyotrophic lateral sclerosis
8 on or after October 1, 2023.

9 (b) REPORT ON ADDITIONAL MEDICAL CONDI-10 TIONS.—

11 (1) REPORT REQUIRED.—Not later than 180 12 days after the date of enactment of this Act, the 13 Secretary of Veterans Affairs shall submit to Con-14 gress a report that includes an identification of any 15 service-connected disability, other than amyotrophic 16 lateral sclerosis, that the Secretary determines 17 treated in the should be same manner as 18 amyotrophic lateral sclerosis is treated under sub-19 paragraphs (B) and (C) of section 1311(a)(2) of 20 title 38, United States Code, as added by subsection 21 (a).

22 (2) CONTENTS.—The report required by sub-23 section (a) shall include the following:

24 (A) A comprehensive list of service-con25 nected disabilities with mortality rates exceed-

ing 95 percent within eight years of diagnoses
 of persons with each such disability.

3 (B) Detailed information on the average
4 life expectancy for persons with each such dis5 ability.

6 (c) MODIFICATION OF CERTAIN HOUSING LOAN
7 FEES.—The loan fee table in section 3729(b)(2) of title
8 38, United States Code, is amended by striking "Novem9 ber 15, 2031" each place it appears and inserting "De10 cember 2, 2031".
