1SEC. 10\_\_\_\_. PROHIBITION ON USE OF FUNDS TO CON-2STRUCT OR MODIFY FACILITIES IN THE3UNITED STATES TO HOUSE DETAINEES4TRANSFERRED FROM UNITED STATES NAVAL5STATION, GUANTANAMO BAY, CUBA.

6 (a) IN GENERAL.—No amounts authorized to be ap-7 propriated or otherwise made available for the Depart-8 ment of Defense may be used during the period beginning 9 on the date of the enactment of this Act and ending on December 31, 2021, to construct or modify any facility 10 in the United States, its territories, or possessions to 11 house any individual detained at Guantanamo for the pur-12 poses of detention or imprisonment in the custody or 13 14 under the control of the Department of Defense.

(b) EXCEPTION.—The prohibition in subsection (a)
shall not apply to any modification of facilities at United
States Naval Station, Guantanamo Bay, Cuba.

(c) INDIVIDUAL DETAINED AT GUANTANAMO DEFINED.—In this section, the term "individual detained at
Guantanamo" has the meaning given that term in section
1034(f)(2) of the National Defense Authorization Act for
Fiscal Year 2016 (Public Law 114–92; 129 Stat. 971; 10
U.S.C. 801 note).

SEC. 11. EXTENSION OF PROHIBITION ON USE OF FUNDS
 TO CLOSE OR RELINQUISH CONTROL OF
 UNITED STATES NAVAL STATION, GUANTA NAMO BAY, CUBA.

Section 1036 of the National Defense Authorization
Act for Fiscal Year 2018 (Public Law 115–91; 131 Stat.
1551), as most recently amended by section 1045 of the
National Defense Authorization Act for Fiscal Year 2020
(Public Law 116–92), is further amended by striking "fiscal year 2018, 2019, or 2020" and inserting "fiscal years
2018 through 2021".
