

AMENDMENT TO RULES COMM. PRINT 118-10
OFFERED BY MR. SMITH OF NEW JERSEY

At the end of subtitle B of title XIII, add the following:

1 **SEC. __. REPORT ON ACTIVITY OF THE PEOPLE'S LIBERA-**
2 **TION ARMY, THE CHINESE COMMUNIST**
3 **PARTY AND GOVERNMENT OF THE PEOPLE'S**
4 **REPUBLIC OF CHINA IN CAMBODIA.**

5 (a) IN GENERAL.—Not later than 180 days after the
6 date of the enactment of this Act, the President shall sub-
7 mit to the congressional committees specified in subsection
8 (c) a report assessing—

9 (1) the involvement of the Government of the
10 People's Republic of China (PRC), the Chinese
11 Communist Party (CCP) or the People's Liberation
12 Army (PLA) (used herewith to include the People's
13 Liberation Army Navy) in upgrading existing facili-
14 ties or constructing new facilities at Ream Naval
15 Base and Dara Sakor Airport in Cambodia;

16 (2) any actual or projected benefits, including
17 any enhancement of the power projection capabilities
18 of the PLA, that the Government of the PRC, the

1 CCP or the PLA may accrue as a result of such up-
2 grades or construction;

3 (3) the impact that the presence of the PLA in
4 Cambodia may have on the interests, allies, and
5 partners of the United States in the region;

6 (4) any efforts undertaken by the United States
7 Government to convey to the Government of Cam-
8 bodia the concerns relating to the presence of the
9 PLA and the Government of the PRC in Cambodia
10 and the impact that presence could have on security
11 in the South China Sea and the Indo-Pacific region
12 more broadly and on adherence to the Constitution
13 of Cambodia;

14 (5) the impact the presence of the PLA in
15 Cambodia, as well as closer government-to-govern-
16 ment ties between Cambodia and the Government of
17 the PRC, including through investments under the
18 Belt and Road Initiative, has had on the deteriora-
19 tion of democracy and human rights inside Cam-
20 bodia;

21 (6) any party-to-party training, coordination or
22 other links between the CCP and the Cambodian
23 People's Party; and

1 (7) any other ongoing activities by the PLA or
2 any other security services of the Government of the
3 PRC in Cambodia.

4 (b) FORM.—The report required by subsection (a)
5 shall be submitted in unclassified form but may include
6 a classified annex.

7 (c) CONGRESSIONAL COMMITTEES SPECIFIED.—The
8 congressional committees specified in this subsection
9 are—

10 (1) the Committee on Foreign Relations, the
11 Committee on Armed Services, and the Select Com-
12 mittee on Intelligence of the Senate; and

13 (2) the Committee on Foreign Affairs, the
14 Committee on Armed Services, and the Permanent
15 Select Committee on Intelligence of the House of
16 Representatives.
