"(ii) LOANS TO REFINANCE A MORT-3 4 GAGE.—A small business concern, home-5 owner, or nonprofit entity that received a 6 loan pursuant to subsection (b)(1)(B) to 7 refinance a mortgage or other lien against 8 a home or business concern that was to-9 tally destroyed or substantially damaged by 10 or as a result of Superstorm Sandy may 11 Superstorm Sandy CDBG-DR receive 12 grant funds only if the amount of such 13 grant funds will be used to repay the 14 amount received under such subsection 15 (b)(1)(B).
