

AMENDMENT TO RULES COMMITTEE PRINT 116-

OFFERED BY MS. SPANBERGER OF VIRGINIA

At the end of subtitle B of title V, add the following new section:

1 **SEC. 5__ . AUTHORITY FOR ESTABLISHMENT OF ADDI-**
2 **TIONAL UNITS OF JUNIOR RESERVE OFFI-**
3 **CERS' TRAINING CORPS.**

4 (a) IN GENERAL.—From amounts authorized to be
5 appropriated by subsection (b) and in accordance with sec-
6 tion 2031 of title 10, United States Code, the Secretaries
7 of the military departments shall seek to establish a total
8 of 100 units of the Junior Reserve Officers' Training
9 Corps at qualifying schools selected by the Secretary con-
10 cerned based on merit from the department's wait list of
11 schools seeking to host such units. The units of the Junior
12 Reserve Officers' Training Corps authorized to be estab-
13 lished under the preceding sentence shall be in addition
14 to any such units authorized to be established under any
15 other provision of law.

16 (b) FUNDING.—

17 (1) INCREASE IN FUNDING FOR ARMY JROTC.—

1 (A) INCREASE.—Notwithstanding the
2 amounts set forth in the funding tables in divi-
3 sion D, the amount authorized to be appro-
4 priated in section 301 for operation and main-
5 tenance, as specified in the corresponding fund-
6 ing table in section 4301 for operation and
7 maintenance, Army, training and recruiting,
8 Junior Reserve Officer Training Corps, line 370
9 is hereby increased by \$9,000,000.

10 (B) OFFSET.—Notwithstanding the
11 amounts set forth in the funding tables in divi-
12 sion D, the amount authorized to be appro-
13 priated in section 301 for operation and main-
14 tenance, as specified in the corresponding fund-
15 ing table in section 4301 for operation and
16 maintenance, Army, admin & service-wide ac-
17 tivities, administration, line 430, is hereby re-
18 duced by \$9,000,000.

19 (2) INCREASE IN FUNDING FOR NAVY JROTC.—

20 (A) INCREASE.—Notwithstanding the
21 amounts set forth in the funding tables in divi-
22 sion D, the amount authorized to be appro-
23 priated in section 301 for operation and main-
24 tenance, as specified in the corresponding fund-
25 ing table in section 4301 for operation and

1 maintenance, Navy, training and recruiting,
2 Junior ROTC, line 430 is hereby increased by
3 \$2,135,955.

4 (B) OFFSET.—Notwithstanding the
5 amounts set forth in the funding tables in divi-
6 sion D, the amount authorized to be appro-
7 priated in section 301 for operation and main-
8 tenance, as specified in the corresponding fund-
9 ing table in section 4301 for operation and
10 maintenance, Navy, admin & service-wide activi-
11 ties, administration, line 440 is hereby reduced
12 by \$2,135,955.

13 (3) INCREASE IN FUNDING FOR AIR FORCE
14 JROTC.—

15 (A) INCREASE.—Notwithstanding the
16 amounts set forth in the funding tables in divi-
17 sion D, the amount authorized to be appro-
18 priated in section 301 for operation and main-
19 tenance, as specified in the corresponding fund-
20 ing table in section 4301 for operation and
21 maintenance, Airforce, training and recruiting,
22 Junior ROTC, line 370 is hereby increased by
23 \$4,375,000.

24 (B) OFFSET.—Notwithstanding the
25 amounts set forth in the funding tables in divi-

1 sion D, the amount authorized to be appro-
2 priated in section 301 for operation and main-
3 tenance, as specified in the corresponding fund-
4 ing table in section 4301 for operation and
5 maintenance, Air Force, admin & service-wide
6 activities, administration, line 400 is hereby re-
7 duced by \$4,375,000.

8 (4) INCREASE IN FUNDING FOR MARINE CORPS
9 JROTC.—

10 (A) INCREASE.—Notwithstanding the
11 amounts set forth in the funding tables in divi-
12 sion D, the amount authorized to be appro-
13 priated in section 301 for operation and main-
14 tenance, as specified in the corresponding fund-
15 ing table in section 4301 for operation and
16 maintenance, Marine Corps, training and re-
17 cruiting, Junior ROTC, line 150 is hereby in-
18 creased by \$2,000,000.

19 (B) OFFSET.—Notwithstanding the
20 amounts set forth in the funding tables in divi-
21 sion D, the amount authorized to be appro-
22 priated in section 301 for operation and main-
23 tenance, as specified in the corresponding fund-
24 ing table in section 4301 for operation and
25 maintenance, Marine Corps, admin & service-

1 wide activities, administration, line 170 is here-
2 by reduced by \$2,000,000.

3 (c) SUPPLEMENT NOT SUPPLANT.—The amounts
4 authorized to be appropriated under subsection (b) are in
5 addition to any other amounts authorized to be appro-
6 priated for fiscal year 2020 for the Department under any
7 other provision of law.
