CERTIFICATION ON ENSURING NO HUMAN 12 RIGHTS ABUSES. 13 The Secretary of Commerce shall certify that no funds for programs related to reducing greenhouse gas 15 emissions authorized under this title, or amendments 16 made by this title, are used for minerals sourced or processed with child labor, as such term is defined in Article 17 18 3 of the International Labor Organization Convention concerning the prohibition and immediate action for the elimination of the worst forms of child labor (December 2, 20 2000), or in violation of human rights.
