At the end of subtitle H of title V, add the following new section:

5 (a) PROHIBITION ON PORNOGRAPHY AND RADICAL

8 fiscal year 2025 or any fiscal year thereafter for the De9 partment of Defense Education Activity may be obligated
10 or expended to purchase, maintain, or display in a school
11 library or classroom—

- (1) any material that contains, depicts, or oth-erwise includes pornographic content; or
- 14 (2) any material that espouses, advocates, or15 promotes radical gender ideology.

16 (b) DEADLINE FOR REMOVAL.—The Director of the
17 Department of Defense Education Activity shall ensure
18 that any material described in subsection (a) that this is

in a library or classroom of a school operated by the Activ ity is removed not later than 30 days after the date of
 the enactment of this Act.

4 (c) DEFINITIONS.—In this section:

(1) The term "pornographic content" means 5 6 any virtual-reality technology, video, image, drawing, 7 sound, instruction, reading material, writing material, presented via any medium in a classroom, 8 9 school library, on school grounds, or as part of a 10 school-sponsored or school-affiliated event that de-11 picts, describes, or presents, in whole or in part— 12 (A) nudity, sex organs, or sexual acts; 13 (B) obscenity; 14 (C) indecent material (as defined by the 15 Secretary of Defense taking into consideration 16 applicable Federal regulations); or 17 (D) lewd or sexual acts in a manner in-18 tended to cause sexual arousal. 19 (2) The term "radical gender ideology" means 20 any concept, teaching, instruction, or curriculum 21 that-22 (A) states or suggests biological sex is a

1	(B) states or suggests biological sex is
2	fluid, interchangeable, or exists beyond the bi-
3	nary of male and female;
4	(C) states or suggests that an individual
5	can be trapped in the wrong body or have a dif-
6	ferent identity than that of their biological sex;
7	(D) encourages, promotes, or advocates the
8	use of personal pronouns unaligned with an in-
9	dividual's biological sex; or
10	(E) encourages, promotes, or advocates
11	hormone replacement, puberty blockers, or gen-
12	der reassignment surgery as a safe, necessary,
13	or optional treatment for an individual.
