Add at the end of subtitle A of title XVII of division A the following:

1	SEC. 1703. WORKING GROUP TO COUNTER CERTAIN
2	THREATS POSED TO THE UNITED STATES BY
3	THE CHINESE COMMUNIST PARTY.
4	(a) Establishment.—
5	(1) In general.—Not later than 180 days
6	after the date of the enactment of this Act, the Sec-
7	retary of Homeland Security shall establish in the
8	Department of Homeland Security a working group
9	(in this section referred to as the "Working
10	Group"), which shall carry out the duties specified
11	in subsection (b) relating to countering terrorist, cy-
12	bersecurity, border and port security, and transpor-
13	tation security threats posed to the United States by
14	the Chinese Communist Party.
15	(2) Director.—
16	(A) APPOINTMENT.—The head of the
17	Working Group shall be a Director (in this sec-
18	tion referred to as the "Director"), who shall be

1	appointed by the Secretary of Homeland Secu-
2	rity.
3	(B) Reporting.—The Director shall re-
4	port to the Secretary of Homeland Security re-
5	garding all administrative, operational, and se-
6	curity matters of the Working Group.
7	(3) Staffing.—The Secretary of Homeland
8	Security shall ensure the Working Group is provided
9	with the following:
10	(A) A sufficient number of employees to
11	perform required duties.
12	(B) Not fewer than one employee dedicated
13	to ensuring compliance with privacy laws and
14	regulations.
15	(4) Detailes.—The Working Group may ac-
16	cept and employ detailees with expertise in coun-
17	tering terrorist, cybersecurity, border and port secu-
18	rity, and transportation security threats posed by
19	the Chinese Communist Party to the United States,
20	or in related fields, from any element of the intel-
21	ligence community or any other Federal agency the
22	Director determines appropriate, with or without re-
23	imbursement, consistent with applicable laws and
24	regulations regarding such employees.

1	(b) Duties.—The Working Group shall carry out the
2	following:
3	(1) Examine, assess, and report upon efforts by
4	the Department of Homeland Security to counter
5	terrorist, cybersecurity, border and port security,
6	and transportation security threats posed to the
7	United States by the Chinese Communist Party, in-
8	cluding efforts to counter the Chinese Communist
9	Party's—
10	(A) nontraditional tactics and exploitation
11	of the United States immigration system
12	through—
13	(i) identity theft;
14	(ii) the immigrant and nonimmigrant
15	visa processes;
16	(iii) unlawful border crossings;
17	(iv) human smuggling; and
18	(v) human trafficking;
19	(B) predatory economic and trade prac-
20	tices, including the trafficking of counterfeit
21	and pirated goods, the use of forced labor, labor
22	exploitation for financial gain, customs fraud,
23	and theft of intellectual property and tech-
24	nology;

1	(C) direct or indirect support for
2	transnational criminal organizations trafficking
3	in fentanyl, illicit drug precursors, or other con-
4	trolled substances through—
5	(i) the United States border;
6	(ii) international mail shipments; or
7	(iii) express consignment operations;
8	and
9	(D) support for illicit financial activity by
10	Chinese Money Laundering Organizations, in-
11	cluding any repatriation to China or any other
12	country of the proceeds derived from the activi-
13	ties described in subparagraphs (A) through
14	(C).
15	(2) Account for the resources of the Depart-
16	ment that are dedicated to programs aimed at coun-
17	tering terrorist, cybersecurity, border and port secu-
18	rity, and transportation security threats posed to the
19	United States by the Chinese Communist Party, and
20	any supporting information as to the efficacy of each
21	such program.
22	(3) Build upon existing or ongoing evaluations
23	and avoid unnecessary duplication by reviewing the
24	findings, conclusions, and recommendations of other
25	appropriate working groups, committees, commis-

1	sions, or entities established by the Department re-
2	lated to efforts to counter terrorist, cybersecurity,
3	border and port security, and transportation security
4	threats posed to the United States by the Chinese
5	Communist Party.
6	(4) Identify gaps in policies, processes, and ac-
7	tivities of the Department to respond to terrorist,
8	cybersecurity, border and port security, and trans-
9	portation security threats posed to the United States
10	by the Chinese Communist Party.
11	(5) Facilitate cooperation and coordination
12	among offices and components of the Department on
13	a holistic response to countering terrorist, cybersecu-
14	rity, border and port security, and transportation se-
15	curity threats posed to the United States by the Chi-
16	nese Communist Party.
17	(e) Additional Duty Relating to Information
18	Sharing.—The Working Group shall review, in coordina-
19	tion with the Office of Intelligence and Analysis of the De-
20	partment of Homeland Security, information relating to
21	terrorist, cybersecurity, border and port security, and
22	transportation security threats posed to the United States
23	by the Chinese Communist Party that is gathered by Fed-
24	eral, State, local, Tribal, and territorial partners, and the
25	National Network of Fusion Centers, and incorporate such

- information, as appropriate, into the Working Group's own information relating to such threats. The Working Group, in coordination with the Office of Intelligence and 3 4 Analysis, shall also ensure the dissemination to Federal, 5 State, local, Tribal, and territorial partners, and the National Network of Fusion Centers, of information related 7 to such threats. 8 (d) Annual Assessments.— 9 (1) In General.—Not later than 180 days 10 after the date of the enactment of this section and 11 annually thereafter for five years, the Secretary of 12 Homeland Security, in coordination with the Under 13 Secretary for Intelligence and Analysis of the De-14 partment of Homeland Security, the Director of the 15 Federal Bureau of Investigation, and the Director of 16 National Intelligence, shall submit to the appro-17 priate congressional committees a report that as-18 sesses terrorist, cybersecurity, border and port secu-19 rity, and transportation security threats posed to the 20 United States by the Chinese Communist Party dur-21 ing the immediately preceding 12 months. (2) Contents.—Each assessment under para-
- 22 (2) CONTENTS.—Each assessment under para 23 graph (1) shall also include the following:

1	(A) A description of the activities and op-
2	erations of the Working Group undertaken pur-
3	suant to subsection (b).
4	(B) Any other matters the Secretary of
5	Homeland Security determines relevant.
6	(3) FORM.—Each assessment under paragraph
7	(1) shall be submitted in unclassified form, but may
8	include a classified annex. The Secretary of Home-
9	land Security shall post on a publicly available
10	website of the Department of Homeland Security the
11	unclassified portion of each assessment.
12	(4) Briefing.—Not later than 30 days after
13	the submission of each assessment under paragraph
14	(1), the Secretary of Homeland Security shall pro-
15	vide to the appropriate congressional committees a
16	briefing on such assessment and the progress and
17	challenges of the Working Group.
18	(e) Comptroller General Review.—Not later
19	than one year after the date of the enactment of this Act,
20	the Comptroller General of the United States shall submit
21	to the appropriate congressional committees a report on
22	the implementation of this section.
23	(f) RESEARCH AND DEVELOPMENT.—Not later than
24	one year after the date of the enactment of this Act, the
25	Secretary of Homeland Security, in coordination with the

1	Director and the Under Secretary for Science and Tech-
2	nology of the Department of Homeland Security, shall, to
3	the extent practicable, carry out research and develop-
4	ment, including operational testing, of technologies and
5	techniques for enhancing the Department's security and
6	situational awareness relating to countering terrorist, cy-
7	bersecurity, border and port security, and transportation
8	security threats posed to the United States by the Chinese
9	Communist Party.
10	(g) Implementation.—All activities carried out
11	pursuant to this section—
12	(1) shall be carried out in accordance with ap-
13	plicable constitutional, privacy, civil rights, and civil
14	liberties protections; and
15	(2) may not infringe upon the lawful exercise of
16	free speech by United States persons.
17	(h) Sunset.—The Working Group shall terminate on
18	the date that is seven years after the establishment of the
19	Working Group under subsection $(a)(1)$.
20	(i) Definitions.—In this section:
21	(1) Appropriate congressional commit-
22	TEES.—The term "appropriate congressional com-
23	mittees" means—
24	(A) in the House of Representatives—

1	(i) the Committee on Homeland Secu-
2	rity;

5	(iii) the Committee on Financial Serv-
6	ices;
7	(iv) the Committee on the Judiciary;
8	and
9	(v) the Committee on Foreign Affairs;
10	and
11	(B) in the Senate—
12	(i) the Committee on Homeland Secu-
13	rity and Governmental Affairs;
14	(ii) the Committee on Banking, Hous-
15	ing, and Urban Affairs;
16	(iii) the Committee on Finance;
17	(iv) the Committee on the Judiciary;
18	and
19	(v) the Committee on Foreign Rela-
20	tions.
21	(2) Fusion center.—The term "fusion cen-
22	ter" has the meaning given such term in subsection
23	(k) of section 210A of the Homeland Security Act
24	of 2002 (6 U.S.C. 124h).

1	(3) Intelligence community.—The term
2	"intelligence community" has the meaning given
3	such term in section 3(4) of the National Security
4	Act of 1947 (50 U.S.C. 3003(4)).
5	(4) National network of fusion cen-
6	TERS.—The term "National Network of Fusion Cen-
7	ters" means a decentralized arrangement of fusion
8	centers intended to enhance individual State and
9	urban area fusion centers' ability to leverage the ca-
10	pabilities and expertise of all such fusion centers for
11	the purpose of enhancing analysis and homeland se-
12	curity information sharing nationally.
13	(5) United states persons.—The term
14	"United States person" has the meaning given such
15	term in section 1637(d)(10) of the Carl Levin and
16	Howard P. "Buck" McKeon National Defense Au-
17	thorization Act for Fiscal year 2015 (50 U.S.C.
18	1708(d)(10)).
