Page 91, after line 25, insert the following new section:

**1 SEC. 126. TARGETED GRANTS TO LOCAL EDUCATIONAL
2 AGENCIES.**

3 Section 1125(c)(2) (20 U.S.C. 6335(c)(2)) is amend-
