## AMENDMENT TO RULES COMM. PRINT 117–54 OFFERED BY Ms. TITUS OF NEVADA

At the end of title XVII, insert the following:

1	SEC. 17 QUARTERLY BRIEFINGS ON REPLENISHMENT
2	AND REVITALIZATION OF STOCKS OF DEFEN-
3	SIVE AND OFFENSIVE WEAPONS PROVIDED
4	TO UKRAINE.
5	(a) Quarterly Briefings.—The Secretary of De-
6	fense shall provide to the congressional defense commit-
7	tees quarterly briefings, in accordance with subsection (b),
8	on the progress of the Department of Defense toward re-
9	plenishing and sustaining the production capacity and
10	stocks of covered weapons that have been delivered to
11	Ukraine as part of the effort to—
12	(1) support Ukraine's resistance against Rus-
13	sian aggression; and
14	(2) buy down strategic risks.
15	(b) Elements of Briefings.—
16	(1) Briefings on us weapons.—The Sec-
17	retary of Defense shall provide to the congressional
18	defense committees quarterly briefings that include
19	each of the following:

1	(A) A timeline and budgetary estimate for
2	developing and procuring replacement stocks of
3	covered weapons for the United States.
4	(B) An identification of any opportunities
5	to allow vendors to compete for agreements to
6	produce next-generation weapons.
7	(C) An analysis of risks within the indus-
8	trial base that provides support for covered
9	weapons, and detailed options to mitigate those
10	risks.
11	(D) A discussion of options to maximize
12	competition among providers of covered weap-
13	ons and components thereof, and an identifica-
14	tion of any gaps in legal authority to pursue
15	and achieve the objectives of maximizing com-
16	petition and replenishing and sustaining the
17	production capacity of covered weapons.
18	(E) An update on the use of the authori-
19	ties of the Department of Defense to replenish
20	and sustain the production capacity and stocks
21	of covered weapons referred to in subsection
22	(a).
23	(2) Briefing on Weapons of Allies and
24	PARTNERS.—The Secretary of Defense shall provide
25	to the congressional defense committees, the Com-

1	mittee on Foreign Affairs of the House of Rep-
2	resentatives, and the Committee on Foreign Rela-
3	tions of the Senate a briefing on the plan to use au-
4	thorities for—
5	(A) developing and procuring replacement
6	stocks of covered weapons for allies and part-
7	ners of the United States; and
8	(B) advancing the replenishment of weap-
9	ons for such allies and partners that have pro-
10	vided, or are contemplating providing, such
11	weapons to Ukraine.
12	(c) COVERED WEAPON.—In this section, the term
13	"covered weapon" means any weapon other than a covered
14	system, as that term is defined in section 1703(d).
15	(d) TERMINATION.—The requirement to provide
16	quarterly briefings under subsection (b)(1) shall terminate
17	on December 31, 2026.
