

AMENDMENT TO RULES COMM. PRINT 118–36
OFFERED BY MS. TITUS OF NEVADA

At the end of subtitle A of title XVII, add the following new section:

1 **SEC. 17___ . ESTABLISHMENT OF COORDINATOR FOR AF-**
2 **GHAN RELOCATION EFFORTS.**

3 (a) ESTABLISHMENT.—The Secretary of State shall
4 appoint a Coordinator for Afghan Relocation Efforts
5 (“Coordinator”), who shall be responsible for—

6 (1) relocating and resettling eligible Afghan al-
7 lies and facilitating the departure of United States
8 citizens and lawful permanent residents who request
9 United States assistance to leave Afghanistan; and

10 (2) working with other offices of the Depart-
11 ment of State, as well as with appropriate counter-
12 parts at other Federal departments and agencies, to
13 ensure integrated United States support for such re-
14 location efforts.

15 (b) AUTHORITIES.—The Coordinator is authorized—

16 (1) to enter into personal services contracts for
17 a period ending not later than the date described in
18 subsection (e);

1 (2) to extend and maintain through such date
2 personal services contracts entered into pursuant to
3 the authority provided by section 2401 of the Af-
4 ghanistan Supplemental Appropriations Act, 2022
5 (Public Law 117–43);

6 (3) to hire temporary personnel who are United
7 States citizens, except that to the extent possible the
8 Coordinator should use Foreign Service limited ap-
9 pointments to fill such positions both in the United
10 States and abroad in accordance with section 309 of
11 the Foreign Service Act of 1980 (22 U.S.C. 3949);
12 and

13 (4) subject to the availability of appropria-
14 tions—

15 (A) to accept, in the form of reimburse-
16 ment or transfer, amounts from other Federal
17 departments or agencies as appropriate to carry
18 out the duties described in subsection (a); and

19 (B) to reimburse such other departments
20 or agencies as the Coordinator may determine
21 appropriate to carry out such duties.

22 (c) DETAILEES AND ASSIGNEES.—Any Federal Gov-
23 ernment employee may be detailed or assigned to the Of-
24 fice of the Coordinator, with or without reimbursement,
25 consistent with applicable laws and regulations regarding

1 such employee, and such detail or assignment shall be
2 without interruption or loss of status or privilege.

3 (d) NOTIFICATION WITH RESPECT TO TRANSFERS
4 OF FUNDS.—

5 (1) IN GENERAL.—The Coordinator shall notify
6 the appropriate congressional committees of each
7 use of the transfer authority made available under
8 subsection (b)(4)(A) not later than 15 days before
9 the completion of such transfer.

10 (2) APPROPRIATE CONGRESSIONAL COMMIT-
11 TEES.—In this subsection, the term “appropriate
12 congressional committees” means—

13 (A) the Committee on Foreign Affairs and
14 the Committee on Appropriations of the House
15 of Representatives; and

16 (B) the Committee on Foreign Relations
17 and the Committee on Appropriations of the
18 Senate.

19 (e) SUNSET.—This the authorities provided by this
20 section shall terminate on the date that is 3 years after
21 the date of the enactment of this Act.
