

**AMENDMENT TO RULES COMMITTEE PRINT 119-8**  
**OFFERED BY MS. TITUS OF NEVADA**

At the end of subtitle B of title XVII add the following new section:

1 **SEC. 17\_\_ . INTELLIGENCE COMMUNITY ASSESSMENT OF**  
2 **SYRIA.**

3 (a) INTELLIGENCE COMMUNITY ASSESSMENT.—Not  
4 later than 90 days after the date of the enactment of this  
5 Act, the Director of National Intelligence, in consultation  
6 with the Secretary of State, shall produce an intelligence  
7 community assessment with respect to the following:

8 (1) Iranian support of proxy and other partner  
9 and militia forces in Syria.

10 (2) The increased threat posed to Israel, other  
11 regional allies of the United States , and other speci-  
12 fied interests of the United States as a result of  
13 such support.

14 (3) Turkish support to armed groups in Syria.

15 (4) Turkish support for Hamas, including ma-  
16 terial support.

17 (5) Terrorist groups continuing to operate in  
18 Syria independently or within the government secu-  
19 rity apparatus.

1           (6) Efforts to rename or reorganize previously  
2 designated terror groups as new entities.

3           (7) Human rights abuses by armed groups in  
4 Syria towards religious minorities.

5           (8) on threats from non-state armed groups  
6 from Lebanon and Iraq to security in Syria.

7       (b) MATTERS TO BE INCLUDED.—The intelligence  
8 community assessment required under subsection (a) shall  
9 include the following information:

10           (1) A description of Iranian and Iranian-con-  
11 trolled personnel, including Hizballah, Shiite mili-  
12 tias, and the Islamic Revolutionary Guard Corps of  
13 Iran, operating in Syria, including the number and  
14 geographic distribution of such personnel.

15           (2) A description of arms and related material,  
16 including financial and technological capabilities,  
17 transferred by Iran to such Iranian and Iranian-con-  
18 trolled personnel since December 2024, including the  
19 number and type of such arms and related material  
20 and whether such transfer was by land, sea, or air.

21           (3) A description of Turkish-supported armed  
22 groups in Syria since March 2011, including those  
23 groups supported with financial assistance, weapons  
24 smuggling, medical assistance, or other material  
25 support.

1           (4) A description of material support provided  
2           to designated terror groups in Syria, including the  
3           Islamic State of Iraq and Syria.

4           (5) An identification of financial institutions,  
5           businesses, and other persons that provide material  
6           support, including financial support, to such Iranian  
7           and Iranian-controlled personnel and designated ter-  
8           ror groups.

9           (6) An assessment of which groups have di-  
10          rectly targeted United States military personnel and  
11          installations in Syria, including an estimate of the  
12          number of attacks.

13          (7) A description of the weapons being used by  
14          armed forces in Syria, including those provided by  
15          Iran, Lebanon, Turkey, Russia, or China and those  
16          manufactured in Syria.

17          (8) A description of the known chemical weap-  
18          ons stored in Syria and those groups with current  
19          custody of those weapons.

20          (9) A description and security assessment of re-  
21          gional detention facilities in Syria that may be capa-  
22          ble of housing foreign fighters and designated ter-  
23          rorists.

1           (10) An assessment of the provision of goods,  
2           services, or technology transferred by Iran or Tur-  
3           key to armed groups in Syria.

4           (11) The number and a description of weapon  
5           shipments interdicted that were being transported to  
6           or from Syria since December 2024.

7           (12) An identification of foreign persons that  
8           are, based on credible information, facilitating the  
9           transfer of significant financial support or arms or  
10          related material to armed groups in Syria.

11          (13) A description of Turkish involvement in  
12          supporting terror groups, including Hamas, the Is-  
13          lamic State of Iraq and Syria, Hay'at Tahrir al-  
14          Sham, and other entities that threaten regional sta-  
15          bility.

16          (14) A description and assessment of attacks by  
17          Turkish and Turkish-sponsored forces on Kurdish  
18          soldiers, civilians, and critical infrastructure in  
19          Kurdish regions of Syria.

20          (c) SUBMISSION TO CONGRESS.—

21           (1) IN GENERAL.—Upon completion of the in-  
22           telligence community assessment required under  
23           subsection (a), the Director of National Intelligence  
24           shall submit such assessment to the Committee on  
25           Foreign Affairs, the Committee on Financial Serv-

1       ices, the Committee on Armed Services, and the Per-  
2       manent Select Committee on Intelligence of the  
3       House of Representatives and the Committee on  
4       Foreign Relations, the Committee on Banking,  
5       Housing, and Urban Affairs, the Committee on  
6       Armed Services, and the Select Committee on Intel-  
7       ligence of the Senate.

8               (2) FORM.—The assessment required under  
9       paragraph (1) shall be submitted in unclassified  
10      form, but may include a classified annex.

11      (d) STRATEGY.—

12              (1) IN GENERAL.—Not later than 60 days after  
13      completion of the intelligence community assessment  
14      required under subsection (a), the President shall  
15      transmit to Congress a strategy to prevent Iran and  
16      Turkey from expanding the influence and power of  
17      those countries in Syria.

18              (2) MATTERS TO BE INCLUDED.—Such strategy  
19      shall include plans to—

20                  (A) limit Iranian and Iranian-controlled  
21                  personnel, including Hizballah, Shiite militias,  
22                  and the Revolutionary Guard Corps forces of  
23                  Iran, operating in Syria;

1 (B) interdict the sale, supply, or transfer  
2 of weapons from Iran to such Iranian and Ira-  
3 nian-controlled personnel operating in Syria;

4 (C) limit Turkish support for terror groups  
5 operating in Syria, including the provision of  
6 weapons and material support;

7 (D) a plan to limit Turkish support for  
8 terror groups that could threaten United states  
9 personnel within the region and key United  
10 States allies, including Israel;

11 (E) limit designated terror groups from  
12 participating in the future security apparatus of  
13 Syria and limiting United States military inter-  
14 action with any such force; and

15 (F) retain detained terrorist fighters cur-  
16 rently incarcerated in Syria and limit the rise  
17 of new terror groups facilitated by foreign ma-  
18 lign actors.

19 (e) ARMS OR RELATED MATERIAL DEFINED.—In  
20 this section, the term “arms or related material” means—

21 (1) nuclear, biological, chemical, or radiological  
22 weapons or materials or components of such weap-  
23 ons;

24 (2) ballistic or cruise missile weapons or mate-  
25 rials or components of such weapons;

1           (3) destabilizing numbers and types of ad-  
2           vanced conventional weapons and unmanned aerial  
3           threats, including drones, rockets, and mortars;

4           (4) defense articles or defense services (as those  
5           terms are defined section 47 of the Arms Export  
6           Control Act (22 U.S.C. 2794));

7           (5) defense information (as defined in section  
8           644 of the Foreign Assistance Act of 1961 (22  
9           U.S.C. 2403)); or

10          (6) items designated by the President for pur-  
11          poses of the United States Munitions List under sec-  
12          tion 38(a)(1) of the Arms Export Control Act (22  
13          U.S.C. 2778(a)(1)).
