At the appropriate place in subtitle C of title XXVIII, insert the following new section:

1	SEC. 28 ESTABLISHMENT OF TIMELINESS STANDARDS
2	WITH RESPECT TO MAINTENANCE WORK OR-
3	DERS FOR COVERED MILITARY UNACCOM-
4	PANIED HOUSING; ANNUAL REPORT.
5	Section 2839 of the National Defense Authorization
6	Act for Fiscal Year 2024 is amended—
7	(1) in the heading, by adding at the end ";
8	WORK ORDER TIMELINESS STANDARDS";
9	(2) by redesignating subsections (c) through
10	subsection (e) as subsections (d) through (f), respec-
11	tively; and
12	(3) by inserting after subsection (b) the fol-
13	lowing new subsection:
14	"(c) Work Order Timeliness Standards; An-
15	NUAL REPORT.—
16	"(1) IN GENERAL.—Not later than July 1,
17	2026, the Secretary of Defense shall establish De-
18	partment of Defense-wide timeliness standards for

1	the resolution of work orders for covered military
2	unaccompanied housing.
3	"(2) Annual Report.—In conjunction with
4	the submission of the report under subsection (a) for
5	fiscal year 2027, and on an annual basis thereafter
6	during the reporting requirement under such sub-
7	section is effective, the Secretary shall submit to the
8	congressional defense committees a report that in-
9	cludes, for each military installation under the juris-
10	diction of the Secretary, with respect to the fiscal
11	year that precedes the fiscal year during which the
12	report is submitted, an identification of—
13	"(A) the total number of work orders for
14	covered military unaccompanied housing re-
15	solved within a period that complied with the
16	timeliness standards under paragraph (1);
17	"(B) the total number of such work orders
18	resolve within a period that did not comply with
19	such timeliness standards;
20	"(C) the total number of such work orders
21	that remain open at the end of the fiscal year
22	covered by the report;
23	"(D) the total number of work orders com-
24	prising the total numbers under subparagraphs
25	(A) through (C), respectively, that relate to the

1	health and safety of covered military unaccom-
2	panied housing;
3	"(E) the total number of employees with
4	duties that include the maintenance and admin-
5	istration of military unaccompanied housing au-
6	thorized;
7	"(F) the total number of authorized posi-
8	tions for employment with such duties that re-
9	main open at the end of the fiscal year covered
10	by the report; and
11	"(G) the total amount obligated or ex-
12	pended on service contracts for the maintenance
13	and administration of covered military unac-
14	companied housing.".
