

AMENDMENT TO _____
OFFERED BY MS. TOKUDA OF HAWAII

Add at the end (before the short title) the following:

1 **TITLE _____**
2 DEPARTMENT OF HOUSING AND URBAN
3 DEVELOPMENT
4 COMMUNITY PLANNING AND DEVELOPMENT
5 COMMUNITY DEVELOPMENT FUND
6 (INCLUDING TRANSFERS OF FUNDS)

7 For an additional amount for “Community Development
8 Fund”, \$5,000,000,000, to remain available until ex-
9 pended, for the same purposes and under the same terms
10 and conditions as funds appropriated under such heading
11 in title VIII of the Disaster Relief Supplemental Appro-
12 priations Act, 2022 (Public Law 117–43; 135 Stat. 355),
13 except that such amounts shall be for major disasters that
14 occurred in 2023 or 2024 and the fourth, 20th, and 21st
15 provisos under such heading in such Act shall not apply:
16 *Provided*, That of the amounts made available under this
17 heading, \$5,000,000 shall be made available for capacity
18 building and technical assistance, including assistance on
19 contracting and procurement processes, to support States,
20 units of general local government, or Indian tribes (and

1 their subrecipients) that receive allocations related to
2 major disasters under this heading in this Act or any Act
3 enacted before or after the date of enactment of this Act:
4 *Provided further*, That of the amounts made available
5 under this heading, \$10,000,000 shall be transferred, in
6 aggregate, to “Department of Housing and Urban Devel-
7 opment— Program Office Salaries and Expenses—Com-
8 munity Planning and Development” for necessary costs,
9 including information technology costs, of administering
10 and overseeing the obligation and expenditure of amounts
11 made available under this heading in this Act or any Act
12 enacted before or after the date of enactment of this Act
13 that makes amounts available for purposes related to
14 major disasters under such heading: *Provided further*,
15 That of the amounts made available under this heading
16 in this Act, \$3,000,000 shall be transferred in aggregate
17 to “Department of Housing and Urban Development—Of-
18 fice of Inspector General” for necessary costs of overseeing
19 and auditing funds amounts made available under the
20 heading “Community Development Fund” in this Act or
21 any Act enacted before or after the date of enactment of
22 this Act that makes amounts available for purposes re-
23 lated to major disasters under such heading: *Provided fur-*
24 *ther*, That amounts made available under this section and
25 under such heading in such Act may be used by a grantee

1 to assist utilities as part of a disaster-related eligible activ-
2 ity under section 105(a) of the Housing and Community
3 Development Act of 1974 (42 U.S.C. 5305(a)): *Provided*
4 *further*, That the Secretary's determination of unmet
5 needs should consider the best available data on the total
6 cost to reconstruct destroyed properties: *Provided further*,
7 That such amount is designated by the Congress as being
8 for an emergency requirement pursuant to section
9 251(b)(2)(A)(i) of the Balanced Budget and Emergency
10 Deficit Control Act of 1985 (2 U.S.C. 901(b)(2)(A)(i)).
