2	(a) Establishment.—Not later than 2 years after

4	of the United States shall carry out a study on the impact
5	of equity issues associated with per-mile user fee funding
6	systems on the surface transportation system.
7	(b) Contents.—The study under subsection (a)
8	shall include the following with respect to per-mile user
9	fee systems:
10	(1) The financial, social, and other impacts of
11	per-mile user fee systems on individuals, including
12	both men and women drivers, low-income individ-
13	uals, and individuals of different races;
14	(2) The impact that access to alternative modes
15	of transportation, including public transportation,
16	has in carrying out per-mile user fee systems;
17	(3) The ability to access jobs and services,
18	which may include healthcare facilities, child care,
19	education and workforce training, food sources,

1	banking and other financial institutions, and other
2	retail shopping establishments;
3	(4) Equity issues for low-income individuals in
4	urban and rural areas; and
5	(5) Any differing impacts on passenger vehicles
6	and commercial vehicles.
7	(c) Inclusions.—In carrying out the study under
8	subsection (a), the Comptroller General shall include an
9	analysis of the following programs:
10	(1) The State surface transportation system
11	funding pilot program under section 6020 of the
12	FAST Act; and
13	(2) The national surface transportation system
14	funding pilot under section 5402 of this Act.
15	(d) Report.—Not later than 2 years after the date
16	of the enactment after this Act, the Comptroller General
17	shall submit to the Committee on Transportation and In-
18	frastructure of the House of Representatives and the Com-
19	mittee on Environment and Public Works of the Senate,
20	and make publicly available, a report containing the re-
21	sults of the study under subsection (a), including rec-
22	ommendations for how to equitably implement per-mile
23	user fee systems.
24	(e) Definitions.—

1	(1) Per-mile user fee.—The term "per-mile	
2	user fee" means a revenue mechanism that—	
3	(A) is applied to road users operating	
4	motor vehicles on the surface transportation	
5	system; and	
6	(B) is based on the number of vehicle miles	
7	traveled by an individual road user.	
8	(2) Commercial vehicle.—The term "com-	
9	mercial vehicle" has the meaning given the term	
10	commercial motor vehicle in section 31101 of title	
11	49, United States Code.
