## AMENDMENT TO RULES COMM. PRINT 118–36 OFFERED BY MR. TRONE OF MARYLAND

Add at the end of subtitle C of title XVII the following:

1	SEC. 1748. NATIONAL BIODEFENSE ANALYSIS AND COUN-
2	TERMEASURES CENTER.
3	(a) IN GENERAL.—Title III of the Homeland Secu-
4	rity Act of 2002 (6 U.S.C. 181 et seq.) is amended by
5	adding at the end the following:
6	"SEC. 324. NATIONAL BIODEFENSE ANALYSIS AND COUN-
7	TERMEASURES CENTER.
8	"(a) In General.—The Secretary, acting through
9	the Under Secretary for Science and Technology, shall
10	designate the laboratory described in subsection (b) as an
11	additional laboratory pursuant to the authority under sec-
12	tion 308(c)(2), which shall be the lead Federal facility
13	dedicated to defending the United States against biological
14	threats by—
15	"(1) understanding the risks posed by inten-
16	tional, accidental, and natural biological events; and
17	"(2) providing the operational capabilities to
18	support the investigation, prosecution, and preven-
19	tion of biocrimes and bioterrorism.

1	"(b) Laboratory Described.—The laboratory de-
2	scribed in this subsection may be a federally funded re-
3	search and development center—
4	"(1) known, as of the date of enactment of this
5	section, as the 'National Biodefense Analysis and
6	Countermeasures Center';
7	"(2) that may include—
8	"(A) the National Bioforensic Analysis
9	Center, which conducts technical analyses in
10	support of Federal law enforcement investiga-
11	tions; and
12	"(B) the National Biological Threat Char-
13	acterization Center, which conducts experiments
14	and studies to better understand biological
15	vulnerabilities and hazards; and
16	"(3) transferred to the Department pursuant to
17	subparagraphs (A), (D), and (F) of section 303(1)
18	and section $303(2)$ .
19	"(c) Laboratory Activities.—The National Bio-
20	defense Analysis and Countermeasures Center shall—
21	"(1) conduct studies and experiments to better
22	understand current and future biological threats and
23	hazards and pandemics;
24	"(2) provide the scientific data required to as-
25	sess vulnerabilities, conduct risk assessments, and

1	determine potential impacts to guide the develop-
2	ment of countermeasures;
3	"(3) conduct and facilitate the technical foren-
4	sic analysis and interpretation of materials recovered
5	following a biological attack, or in other law enforce-
6	ment investigations requiring evaluation of biological
7	materials, in support of the appropriate lead Federal
8	agency;
9	"(4) coordinate with other national laboratories
10	to enhance research capabilities, share lessons
11	learned, and provide training more efficiently;
12	"(5) collaborate with the Homeland Security
13	Enterprise, as defined in section 2200, to plan and
14	conduct research to address gaps and needs in bio-
15	defense; and
16	"(6) carry out other such activities as the Sec-
17	retary determines appropriate.
18	"(d) Work for Others.—The National Biodefense
19	Analysis and Countermeasures Center shall engage in a
20	continuously operating Work for Others program to make
21	the unique biocontainment and bioforensic capabilities of
22	the National Biodefense Analysis and Countermeasures
23	Center available to other Federal agencies.

1	"(e) Facility Repair and Routine Equipment
2	REPLACEMENT.—The National Biodefense Analysis and
3	Countermeasures Center shall—
4	"(1) perform regularly scheduled and required
5	maintenance of laboratory infrastructure; and
6	"(2) procure mission-critical equipment and ca-
7	pability upgrades.
8	"(f) Facility Mission Needs Assessment.—
9	"(1) In general.—To address capacity con-
10	cerns and accommodate future mission needs and
11	advanced capabilities, the Under Secretary for
12	Science and Technology shall conduct a mission
13	needs assessment, including scoping for potential fu-
14	ture needs or expansion, of the National Biodefense
15	Analysis and Countermeasures Center.
16	"(2) Submission.—Not later than 120 days
17	after the date of enactment of this section, the
18	Under Secretary for Science and Technology shall
19	provide the assessment conducted under paragraph
20	(1) to—
21	"(A) the Committee on Homeland Security
22	and Governmental Affairs and the Sub-
23	committee on Homeland Security Appropria-
24	tions of the Committee on Appropriations of the
25	Senate; and

1	"(B) the Committee on Homeland Security
2	and the Subcommittee on Homeland Security
3	Appropriations of the Committee on Appropria-
4	tions of the House of Representatives.
5	"(g) Authorization of Appropriations.—There
6	is authorized to be appropriated such sums as may be nec-
7	essary to support the activities of the laboratory des-
8	ignated under this section.
9	"(h) Rule of Construction.—Nothing in this sec-
10	tion may be construed as affecting in any manner the au-
11	thorities or responsibilities of the Countering Weapons of
12	Mass Destruction Office of the Department.".
13	(b) CLERICAL AMENDMENT.—The table of contents
14	in section 1(b) of the Homeland Security Act of 2002 is
15	amended by inserting after the item relating to section
16	323 the following new item:
