13	Sec. 5 (a) There is authorized to be appro-
14	priated to the Secretary of the Interior, \$100,000,000 for
15	each of the fiscal years 2023 through 2026 for a grant

1	program for the acceleration and completion of repairs to
2	canal infrastructure facilities in Reclamation States.
3	(b) A project eligible for funding under this section
4	is a project with respect to which—
5	(1) repairs are major, non-recurring mainte-
6	nance;
7	(2) in the case of repairs to conveyance assets,
8	the Secretary, or the Governor of a State, deter-
9	mines that the canal facility has lost 10 percent or
10	more of its designed carrying capacity along some
11	portion of the facility, as a result of land subsidence;
12	(3) restoring carrying capacity of a conveyance
13	asset would assist in meeting groundwater sustain-
14	ability goals defined under State law; or
15	(4) a facility is owned or operated by a State
16	and meets the requirements of subparagraphs (1),
17	(2), and (3) above.
18	(c) The Federal share of the cost of carrying out an
19	activity described in this section shall not be more than
20	50 percent.
21	(d) The non-Federal share of the cost of carrying out
22	an activity described in this section—
23	(1) shall be not less than 50 percent; and
24	(2) may be provided in cash or in kind.

- 1 (e) Funds authorized to be appropriated under this
- 2 section may not be used to build new surface storage or
- 3 raise existing reservoirs.
- 4 (f) Federal funds provided under this section shall
- 5 be in addition to any and all Federal funding authorized
- 6 in statute for such purposes, and shall be non-reimburs-
- 7 able.
- 8 (g) In this section, the term "Reclamation State" has
- 9 the meaning given such term in section 4014 of the Water
- 10 Infrastructure Improvements for the Nation Act (Public
- 11 Law 114–322; 43 U.S.C. 390b note).
