At the end of subtitle G of title X, insert the following:

1	SEC. 10 EXPRESSING SUPPORT FOR THE DESIGNATION
2	OF NOVEMBER 12, 2023, AS "NATIONAL WAR-
3	RIOR CALL DAY".
4	(a) FINDINGS.—Congress makes the following find-
5	ings:
6	(1) Establishing an annual "National Warrior
7	Call Day" will draw attention to the members of the
8	Armed Forces whose connection to one another is
9	key to the veterans and first responders in the
10	United States who may be dangerously disconnected
11	from family, friends, and support systems.
12	(2) The number of suicides of members of the
13	Armed Forces serving on active duty increased to
14	377 in 2020, an increase from 348 in 2019.
15	(3) The suicide rate for veterans has steadily
16	increased since 2006, with 6,261 veterans taking
17	their own lives in 2019.

(4) After adjusting for sex and age, the rate of
 veteran suicide in 2018 was 27.5 per 100,000 indi viduals, higher than the rate among all United
 States adults, which was 18.3 per 100,000 individ uals.

6 (5) More veterans have died by suicide in the 7 last 10 years than members of the Armed Forces 8 who died from combat in Vietnam; Whereas many of 9 the veterans who take their own lives have had no 10 contact with the Department of Veterans Affairs.

(6) The Coronavirus Disease 2019 (COVID12 19) pandemic can lead to increased isolation and
disconnection, further exacerbating mental and physical ailments such as post-traumatic stress disorder
and traumatic brain injury.

16 (7) The Centers for Disease Control and Pre17 vention note that law enforcement officers and fire18 fighters are more likely to die by suicide than in the
19 line of duty, and emergency medical services pro20 viders are 1.39 times more likely to die by suicide
21 than members of the general public.

(8) Invisible wounds linked to an underlying
and undiagnosed traumatic brain injury can mirror
many mental health conditions, a problem that can
be addressed through appropriate medical treatment.

(9) Additional research is needed to highlight
 the connection between traumatic brain injury as a
 root cause of invisible wounds and suicide by mem bers of the Armed Forces and veterans.

5 (10) November 12, 2023, would be an appro6 priate day to designate as "National Warrior Call
7 Day".

8 (b) SENSE OF CONGRESS.—Congress expresses sup-9 port for the designation of November 12, 2023, as the 10 "National Warrior Call Day" and recognizing the impor-11 tance of connecting our warriors to support structures 12 necessary to transitioning from the battlefield.
