## OFFERED BY MR. VEASEY OF TEXAS

At the end of subtitle B of title I, add the following new section:

## 1 SEC. 1\_\_\_\_. FUNDING FOR ADDITIONAL JOINT STRIKE 2 FIGHTER AIRCRAFT.

3 (a) INCREASE.—Notwithstanding the amounts set 4 forth in the funding tables in division D, the amount au-5 thorized to be appropriated in section 101 for aircraft pro-6 curement, Navy, as specified in the corresponding funding table in section 4101, for Joint Strike Fighter CV, line 7 002, is hereby increased by \$354,000,000 (with the 8 9 amount of such increase to used for the procurement of three additional Joint Strike Fighter aircraft). 10
