Add at the end of title LIV of division E the following:

SEC. 5403. BUREAU SERVICEMEMBER AND VETERAN CRED IT REPORTING OMBUDSPERSON.

3 (a) IN GENERAL.—Section 611(a) of the Fair Credit
4 Reporting Act (15 U.S.C. 1681i(a)) is amended by adding
5 at the end the following:

6 "(9) BUREAU SERVICEMEMBER AND VETERAN
7 CREDIT REPORTING OMBUDSPERSON.—

8 "(A) IN GENERAL.—Not later than 180 9 days after the date of enactment of this para-10 graph, the Bureau shall establish the position 11 of servicemember and veteran credit reporting 12 ombudsperson, who shall carry out the Bu-13 reau's responsibilities with respect to—

"(i) resolving persistent errors that
are not resolved in a timely manner by a
consumer reporting agency in connection
with servicemembers and veterans; and

1	"(ii) enhancing oversight of consumer
2	reporting agencies by—
3	"(I) advising the Director of the
4	Bureau, in consultation with the Of-
5	fice of Enforcement and the Office of
6	Supervision of the Bureau, on any po-
7	tential violations of paragraph (5) or
8	any other applicable law by a con-
9	sumer reporting agency in connection
10	with servicemembers and veterans, in-
11	cluding appropriate corrective action
12	for such a violation; and
13	"(II) making referrals to the Of-
14	fice of Supervision for supervisory ac-
15	tion or the Office of Enforcement for
16	enforcement action, as appropriate, in
17	response to violations of paragraph
18	(5) or any other applicable law by a
19	consumer reporting agency in connec-
20	tion with servicemembers and vet-
21	erans.
22	"(B) Consultation with veterans
23	SERVICE ORGANIZATIONS.—The servicemember
24	and veteran credit reporting ombudsperson

shall consult with veterans service organizations in carrying out the duties of the ombudsperson.

3 "(C) REPORT.—The ombudsperson shall submit to the Committees on Financial Services 4 5 and Veterans' Affairs of the House of Rep-6 resentatives and the Committees on Banking, 7 Housing, and Urban Affairs and Veterans' Af-8 fairs of the Senate an annual report including 9 statistics and analysis on consumer complaints 10 the Bureau receives relating to consumer re-11 ports in connection with servicemembers and 12 veterans, as well as a summary of the super-13 visory actions and enforcement actions taken 14 with respect to consumer reporting agencies in 15 connection with servicemembers and veterans 16 during the year covered by the report.".

17 (b) DISCRETIONARY SURPLUS FUNDS.—

18 (1) IN GENERAL.—The dollar amount specified
19 under section 7(a)(3)(A) of the Federal Reserve Act
20 (12 U.S.C. 289(a)(3)(A)) is reduced by
21 \$18,000,000.

(2) EFFECTIVE DATE.—The amendment made
by paragraph (1) shall take effect on September 30,
2032.
