## **AMENDMENT TO**

## RULES COMMITTEE PRINT 116–57 OFFERED BY MR. WALBERG OF MICHIGAN

At the end of subtitle E of title XVII, add the following new section:

1	SEC. 17 REPRESENTATION AND LEADERSHIP OF
2	UNITED STATES IN COMMUNICATIONS
3	STANDARDS-SETTING BODIES.
4	(a) In General.—In order to enhance the represen-
5	tation of the United States and promote United States
6	leadership in standards-setting bodies that set standards
7	for 5G networks and for future generations of wireless
8	communications networks, the Assistant Secretary shall,
9	in consultation with the National Institute of Standards
10	and Technology—
11	(1) equitably encourage participation by compa-
12	nies and a wide variety of relevant stakeholders, but
13	not including any company or relevant stakeholder
14	that the Assistant Secretary has determined to be
15	not trusted, (to the extent such standards-setting
16	bodies allow such stakeholders to participate) in
17	such standards-setting bodies; and

1	(2) equitably offer technical expertise to compa-
2	nies and a wide variety of relevant stakeholders, but
3	not including any company or relevant stakeholder
4	that the Assistant Secretary has determined to be
5	not trusted, (to the extent such standards-setting
6	bodies allow such stakeholders to participate) to fa-
7	cilitate such participation.
8	(b) STANDARDS-SETTING BODIES.—The standards-
9	setting bodies referred to in subsection (a) include—
10	(1) the International Organization for Stand-
11	ardization;
12	(2) the voluntary standards-setting bodies that
13	develop protocols for wireless devices and other
14	equipment, such as the 3GPP and the Institute of
15	Electrical and Electronics Engineers; and
16	(3) any standards-setting body accredited by
17	the American National Standards Institute or Alli-
18	ance for Telecommunications Industry Solutions.
19	(c) Briefing.—Not later than 60 days after the date
20	of the enactment of this Act, the Assistant Secretary shall
21	brief the Committee on Energy and Commerce of the
22	House of Representatives and the Committee on Com-
23	merce, Science, and Transportation of the Senate on a
24	strategy to carry out subsection (a).
25	(d) DEFINITIONS.—In this section:

1	(1) 3GPP.—The term "3GPP" means the 3rd
2	Generation Partnership Project.
3	(2) 5G Network.—The term "5G network"
4	means a fifth-generation mobile network as de-
5	scribed by 3GPP Release 15 or higher.
6	(3) Assistant secretary.—The term "Assist-
7	ant Secretary' means the Assistant Secretary of
8	Commerce for Communications and Information.
9	(4) CLOUD COMPUTING.—The term "cloud
10	computing" has the meaning given the term in Spe-
11	cial Publication 800–145 of the National Institute of
12	Standards and Technology, entitled "The NIST Def-
13	inition of Cloud Computing", published in Sep-
14	tember 2011, or any successor publication.
15	(5) Communications network.—The term
16	"communications network" means any of the fol-
17	lowing:
18	(A) A system enabling the transmission,
19	between or among points specified by the user,
20	of information of the user's choosing.
21	(B) Cloud computing resources.
22	(C) A network or system used to access
23	cloud computing resources.
24	(6) Not trusted.—The term "not trusted"
25	means, with respect to a company or stakeholder,

1	that the company or stakeholder is determined by
2	the Assistant Secretary to pose a threat to the na-
3	tional security of the United States. In making such
4	a determination, the Assistant Secretary shall rely
5	solely on one or more of the following determina-
6	tions:
7	(A) A specific determination made by any
8	executive branch interagency body with appro-
9	priate national security expertise, including the
10	Federal Acquisition Security Council estab-
11	lished under section 1322(a) of title 41, United
12	States Code.
13	(B) A specific determination made by the
14	Department of Commerce pursuant to Execu-
15	tive Order No. 13873 (84 Fed. Reg. 22689; re-
16	lating to securing the information and commu-
17	nications technology and services supply chain).
18	(C) Whether a company or stakeholder
19	produces or provides covered telecommuni-
20	cations equipment or services, as defined in sec-
21	tion 889(f)(3) of the John S. McCain National
22	Defense Authorization Act for Fiscal Year 2019
23	(Public Law 115–232; 132 Stat. 1918).
