

AMENDMENT TO H.R. 4346, AS REPORTED
OFFERED BY MS. WEXTON OF VIRGINIA

At the end of the bill (before the short title), insert the following:

1 PLAQUE TO HONOR LAW ENFORCEMENT AGENCIES

2 RESPONDING TO ATTACK ON CAPITOL

3 SEC. _____. (a) SENSE OF CONGRESS.—It is the
4 sense of the Congress that the United States owes its
5 deepest gratitude to those United States Capitol Police
6 and Washington, DC, Metropolitan Police Department of-
7 ficers, as well as officers from multiple Federal, State, and
8 local law enforcement agencies, who valiantly protected the
9 United States Capitol, Members of Congress, and staff on
10 January 6, 2021.

11 (b) PLAQUE.—The Architect of the Capitol shall ob-
12 tain an honorific plaque that commends the examples of
13 bravery and service-above-self demonstrated by officers of
14 the United States Capitol Police, the Metropolitan Police
15 Department of the District of Columbia, and the multiple
16 Federal, State, and local law enforcement agencies and
17 protective entities on the list compiled under subsection
18 (c) that joined alongside of them during the January 6,
19 2021 attack on the United States Capitol, and shall place

1 the plaque at a permanent location on the western front
2 of the United States Capitol.

3 (c) LIST OF AGENCIES.—

4 (1) COMPILATION.—The Committee on House
5 Administration of the House of Representatives and
6 the Committee on Rules and Administration of the
7 Senate shall jointly compile a list of Federal, State,
8 and local law enforcement agencies and protective
9 entities whose names should be included on the
10 plaque under subsection (b).

11 (2) SPECIFIC FEDERAL AGENCIES AND ENTI-
12 TIES INCLUDED.—The list compiled under para-
13 graph (1) shall include each of the following Federal
14 law enforcement agencies and protective entities:

15 (A) The United States Capitol Police.

16 (B) The National Guard Bureau, Depart-
17 ment of Defense.

18 (C) The Department of Homeland Secu-
19 rity.

20 (D) The Bureau of Alcohol, Tobacco, Fire-
21 arms and Explosives.

22 (E) The Federal Bureau of Investigation.

23 (F) The Pentagon Force Protection Agen-
24 cy, Department of Defense.

25 (G) The United States Secret Service.

1 (H) The United States Park Police.

2 (I) The United States Marshals Service.

3 (J) The Department of Health and Human
4 Services.

5 (3) SPECIFIC STATE AND LOCAL LAW AGENCIES
6 INCLUDED.—The list compiled under paragraph (1)
7 shall include each of the following State and local
8 law enforcement agencies:

9 (A) Metropolitan Police Department of the
10 District of Columbia.

11 (B) Metropolitan Washington Airports Au-
12 thority.

13 (C) Metro Transit Police Department,
14 Washington Metropolitan Area Transit Author-
15 ity.

16 (D) Virginia State Police.

17 (E) Fairfax County, Virginia, Police De-
18 partment.

19 (F) Prince William County, Virginia, Po-
20 lice Department.

21 (G) Arlington County, Virginia, Police De-
22 partment.

23 (H) Maryland Department of State Police.

24 (I) Prince George's County, Maryland, Po-
25 lice Department.

1 (J) Montgomery County, Maryland, De-
2 partment of Police.

3 (K) New Jersey State Police.

4 (4) CONFIRMATION.—The Committee on House
5 Administration of the House of Representatives and
6 the Committee on Rules and Administration of the
7 Senate shall work with the agencies and entities de-
8 scribed in paragraphs (2) and (3) to confirm the ac-
9 curacy of the list compiled under this section.

10 (d) PRESENTATION OF MATCHING PLAQUES TO
11 AGENCIES AND ENTITIES.—For each of the law enforce-
12 ment agencies and protective entities whose name is in-
13 cluded on the plaque under subsection (b), the Architect
14 of the Capitol shall obtain and present a plaque which
15 matches the plaque under subsection (b).
