(a) PILOT PROGRAM.—No later than March 31,
2024, the Chief Digital and Artificial Intelligence Officer
shall initiate a pilot program to determine the optimal approach to the test and evaluation of large language models
for the Department of Defense.

9 (b) PROTOTYPE RECOMMENDATION.—Under the
10 pilot program, Chief Digital and Artificial Intelligence Of11 ficer shall carry out the following activities:

12 (1) The Chief Digital and Artificial Intelligence 13 Officer shall seek to enter into one or more contracts 14 with private sector entities to conduct studies to 15 identify the optimal approach for the testing and 16 evaluation of large language models for the Depart-17 ment of Defense. Each such study shall consider 18 methods the Department may use to evaluate large 19 language models with respect to2

7	(2) Each entity that enters into a contract with

11	(3) No later than 30 days after receiving all re-
12	ports required under paragraph (2), the Chief Dig-
13	ital and Artificial Intelligence Officer may enter into
14	a contract, of no longer than 180 days in duration,
15	with a private sector entity that conducted one of
16	the studies under paragraph (1) pursuant to which
17	the entity will build test and evaluation prototypes
18	based on the findings of such studies.
19	(c) Report to Congress.—No later than 90 days
20	after completion of the prototyping activities described in
21	subsection (b)(3), the the Chief Digital and Artificial In-
22	telligence Officer shall submit to the Committees on
23	Armed Services of the Senate and the House of Represent-
24	atives a report that includes—

9 (d) FORM OF REPORT.—The report under subsection
10 (c) shall be submitted in unclassified form, but may in11 clude a classified annex.
