## **AMENDMENT TO**

## RULES COMMITTEE PRINT 116–57 OFFERED BY MR. HECK OF WASHINGTON

At the end of subtitle I of title V, add the following:

1	SEC. 5 ESTABLISHMENT OF WOUNDED KNEE MEDAL OF
2	HONOR REVIEW BOARD.
3	(a) Establishment.—Not later than 60 days after
4	the date of the enactment of this Act, the Secretary of
5	Defense shall establish an advisory board to be known as
6	the "Wounded Knee Medal of Honor Review Board" (in
7	this section referred to as the "Board").
8	(b) Duties and Powers.—The duties and powers
9	of the Board are the following:
10	(1) To review the military service records of
11	each individual awarded the Medal of Honor for acts
12	at Wounded Knee Creek, Lakota Pine Ridge Indian
13	Reservation, South Dakota, on December 29, 1890.
14	(2) To review any other records in the custody
15	of the Secretary of Defense related to the awarding
16	of a Medal of Honor described in paragraph (1).
17	(3) To determine, by a vote of not fewer than
18	two members, whether any individual described in
19	paragraph (1) received such award for a reason

- 1 other than service described in section 7271, 8291,
- or 9271 of title 10, United States Code.
- 3 (c) Access to Government Records.—The Sec-
- 4 retary of Defense shall provide the Board with records de-
- 5 scribed in subsection (b).
- 6 (d) Consultation.—In carrying out its duties, the
- 7 Board shall seek to consult with groups of indigenous indi-
- 8 viduals, Tribal officials, and historians of the United
- 9 States and the Armed Forces.
- 10 (e) Membership.—The Secretary of Defense shall
- 11 appoint as members of the Board seven retired general
- 12 or flag officers who volunteer to serve without compensa-
- 13 tion.
- 14 (f) REPORT OF THE BOARD.—Not later than one
- 15 year after the establishment of the Board under sub-
- 16 section (a), the Board shall submit to the Secretary of De-
- 17 fense and the Committees on Armed Services of the Sen-
- 18 ate and House of Representatives a report containing the
- 19 findings and recommendations of the Board, including the
- 20 name, if any, of an individual described in subsection
- 21 (b)(3).
- 22 (g) Termination.—The Board shall terminate upon
- 23 submittal of the report under subsection (f).
- 24 (h) ACTION OF THE SECRETARY.—Not later than 30
- 25 days after receiving the report under subsection (f), the

  - 6 (b)(3).
  - 7 (i) Return of Medal Not Required.—No person
  - 8 may be required to return to the Federal Government a
  - 9 Medal of Honor under this section.
- 10 (j) No Denial of Benefits.—This section shall not
- 11 be construed to deny any individual any benefit from the
- 12 Federal Government.
