Such eligibility shall be restored 20 21 whether or not payment to such child or children subse-22 quently was terminated due to loss of dependent status 23 or death. For the purposes of this subsection, an eligible spouse includes a spouse who was previously eligible for payment of such annuity and is not remarried, or remar-
