

AMENDMENT TO RULES COMM. PRINT 119-8
OFFERED BY MR. STEUBE OF FLORIDA

At the end of subtitle A of title XVII, add the following:

1 SEC. 17 ____ . DESIGNATION AS FOREIGN TERRORIST ORGA-
2 NIZATIONS; IMPOSITION OF SANCTIONS.

3 (a) DESIGNATION AS FTO.—Not later than 90 days
4 after the date of the enactment of this Act, the Secretary
5 of State shall designate as a foreign terrorist organization
6 pursuant to section 219(a) of the Immigration and Na-
7 tionality Act (8 U.S.C. 1189(a)) each of the following:

- 8 (1) Abu Fadl al-Abbas Brigades.**
- 9 (2) Badr Organization.**
- 10 (3) Fatemiyoun Brigade.**
- 11 (4) Harakat Hezbollah al-Nujaba.**
- 12 (5) Kata"ib al-Imam Ali.**
- 13 (6) Kata"ib Jund al-Imam.**
- 14 (7) Kata"ib Sayyad al Shuhada.**
- 15 (8) Sarayya al-Jihad.**
- 16 (9) Sarayya Khorasani.**
- 17 (10) Zainabiyoun Brigade.**
- 18 (11) Salah al-Din Brigade.**
- 19 (12) Turkmen Brigades.**

23 (b) IMPOSITION OF SANCTIONS.—

24 (1) IN GENERAL.—Not later than 60 days after
25 the date of the enactment of this Act, the President

1 shall determine whether to impose the sanctions de-
2 scribed in paragraph (3) on any organization listed
3 under paragraph (2) or any entity or organization
4 that is an agent, affiliate, or instrumentality, or
5 owned or controlled by an agent, affiliate, or instru-
6 mentality of an organization listed in paragraph (2).

7 (2) ORGANIZATIONS.—The following are organi-
8 zations with respect to which a sanction determina-
9 tion shall be made:

- 22 (L) Saraya al-Salam.
- 23 (M) Talia al-Khurasani.
- 24 (N) Liwa Usud al-Uqaydat.
- 25 (O) Liwa al-Taftuf.

8 (3) SANCTIONS DESCRIBED.—The sanctions de-
9 scribed in this subsection are sanctions applicable
10 with respect to a foreign person pursuant to Execu-
11 tive Order 13224 (50 U.S.C. 1701 note; relating to
12 blocking property and prohibiting transactions with
13 persons who commit, threaten to commit, or support
14 terrorism).

15 (c) REPORT.—

16 (1) SECRETARY OF STATE REPORT.—Not later
17 than 180 days after the date of enactment of this
18 Act, and every 180 days thereafter, the Secretary of
19 State, in consultation with the Secretary of Com-
20 merce, shall submit to Congress a report on any new
21 entities meeting the requirements for—

22 (A) designation as a foreign terrorist orga-
23 nization; or

24 (B) imposition of sanctions with respect to
25 a foreign person pursuant to Executive Order

1 13224 (50 U.S.C. 1701 note; relating to block-
2 ing property and prohibiting transactions with
3 persons who commit, threaten to commit, or
4 support terrorism).

5 (2) PRESIDENTIAL REPORT.—The President
6 shall submit to Congress a report not later than 60
7 days after a determination has been made under
8 subsection (b) on whether the organizations listed
9 under such subsection have sanctions imposed pur-
10 suant to Executive Order 13224 and shall provide a
11 detailed explanation should any such organization
12 not be sanctioned.
