

**AMENDMENT TO RULES COMMITTEE PRINT**

**119–22**

**OFFERED BY MR. NEGUSE OF COLORADO**

At the end of subtitle A, of title IV, add the following:

**1 SEC. 4114. SELF-DETERMINATION FOR SNAP.**

2 (a) SELF-DETERMINATION FOR SNAP.—Title I of  
3 the Indian Self-Determination and Education Assistance  
4 Act (25 U.S.C. 5321 et seq.) is amended by adding at  
5 the end the following:

**6 “SEC. 112. SELF-DETERMINATION FOR SNAP.**

7 “(a) AGRICULTURE SELF-DETERMINATION AUTHOR-  
8 IZED.—The Secretary of Agriculture shall enter into self-  
9 determination contracts, in accordance with subsection  
10 (b), with Indian Tribes and Tribal organizations, on the  
11 request of any Indian Tribe by Tribal resolution, to plan,  
12 conduct, and administer any function, service, or activity  
13 of the supplemental nutrition assistance program estab-  
14 lished under the Food and Nutrition Act of 2008 (7  
15 U.S.C. 2011 et seq.) for the Indian Tribe.

16 “(b) SELF-DETERMINATION CONTRACT.—A self-de-  
17 termination contract entered into under subsection (a)  
18 shall have the same terms and conditions, and be subject

1 to the same procedures, regulations, and requirements, as  
2 a self-determination contract entered into under section  
3 102, except that the Secretary of Agriculture and the De-  
4 partment of Agriculture shall be the appropriate Secretary  
5 and agency for purposes of a self-determination contract  
6 entered into under subsection (a).

7 “(c) **TECHNICAL ASSISTANCE.**—The Office of Self-  
8 Governance of the Bureau of Indian Affairs shall provide  
9 technical assistance regarding the self-determination con-  
10 tracts authorized under this section to—

11 “(1) the Secretary of Agriculture; and

12 “(2) Indian Tribes and Tribal organizations  
13 that request that assistance.”.

14 (b) **SELF-GOVERNANCE FOR SNAP.**—Title IV of the  
15 Indian Self-Determination and Education Assistance Act  
16 (25 U.S.C. 5361 et seq.) is amended by adding at the end  
17 the following:

18 **“SEC. 418. SELF-GOVERNANCE FOR SNAP.**

19 “(a) **AGRICULTURE SELF-GOVERNANCE AUTHOR-**  
20 **IZED.**—The Secretary of Agriculture shall enter into self-  
21 governance compacts and funding agreements, in accord-  
22 ance with subsection (b), with Indian Tribes and Tribal  
23 organizations, on the request of any Indian Tribe by Trib-  
24 al resolution, to plan, conduct, and administer any func-  
25 tion, service, or activity of the supplemental nutrition as-

1 sistance program established under the Food and Nutri-  
2 tion Act of 2008 (7 U.S.C. 2011 et seq.) for the Indian  
3 Tribe.

4       “(b) SELF-GOVERNANCE COMPACT AND FUNDING  
5 AGREEMENT.—A self-governance compact and funding  
6 agreement entered into under subsection (a) shall have the  
7 same terms and conditions, and be subject to the same  
8 procedures, regulations, and requirements, as a self-gov-  
9 ernance compact and funding agreement entered into  
10 under sections 40 and 403, except that the Secretary of  
11 Agriculture and the Department of Agriculture shall be  
12 the appropriate Secretary and agency for purposes of a  
13 self-governance compact and funding agreement under  
14 this section.

15       “(c) TECHNICAL ASSISTANCE.—The Office of Self-  
16 Governance of the Department of the Interior shall pro-  
17 vide technical assistance regarding the self-governance  
18 compacts and funding agreements authorized under this  
19 section to—

20               “(1) the Secretary of Agriculture; and

21               “(2) Indian Tribes and Tribal organizations  
22               that request that assistance.”.
